

**HOUSE COMMITTEE AMENDMENTS**

2019 Regular Session

Amendments proposed by House Committee on Ways and Means to Engrossed Senate Bill No. 72 by Senator Carter

1 AMENDMENT NO. 1

2 On page 1, line 5, after "Legislature" delete the comma "," and insert "or to amend and  
3 reenact R.S. 33:4710.12(A)(introductory paragraph) and to enact R.S. 33:4710.12(A)(1)(f),

4 AMENDMENT NO. 2

5 On page 2, at the end of line 19, delete "**and the state**" and at the beginning of line 20, delete  
6 "**senator who represent the Westbank of Orleans Parish.**" and insert "**who represents**  
7 **House District No. 102 and the state senator who represents Senate District No. 7.**"

8 AMENDMENT NO. 3

9 On page 2, delete line 27, and insert the following:

10 "Section 2. R.S. 33:4710.12(A)(introductory paragraph) is hereby amended  
11 and reenacted and R.S. 33:4710.12(A)(1)(f) is hereby enacted to read as follows:

12 §4710.12. Board of commissioners

13 A. The authority shall be governed by a board of commissioners, hereafter  
14 in this Chapter referred to as the "board", composed of ~~twelve~~ thirteen members  
15 appointed as follows:

16 (1) The governor shall appoint:

18 **(f) One member who resides on the Westbank of Orleans Parish and**  
19 **who has experience or a background in tourism, hospitality, or business, from**  
20 **a list of three names submitted by the state representative who represents House**  
21 **District No. 102 and the state senator who represents Senate District No. 7.**

22 Section 3. References to R.S. 33:4710.12(A) in this Act refer to that  
23 Subsection as enacted in the Act that originated as House Bill No. 617 of this 2019  
24 Regular Session of the Legislature.

25 Section 4. Sections 1 and 2 of this Act are intended to achieve the same  
26 purpose but are drafted differently. Section 1 amends provisions of law as they are  
27 presently. Section 2 amends provisions of law as they will be if House Bill No. 617  
28 of this 2019 Regular Session of the Legislature becomes law. Only one of the two  
29 Sections shall be given effect as follows:

30 (1) If House Bill No. 617 of this 2019 Regular Session of the Legislature  
31 becomes law, the provisions of Section 1 of this Act shall not become effective.

32 (2) If House Bill No. 617 of this 2019 Regular Session of the Legislature  
33 does not become law, the provisions of Section 2 of this Act shall not become  
34 effective.

35 Section 5. Subject to the limitation provided by Section 4 of this Act, this  
36 Act shall become effective upon signature by the governor or, if not"
