MTR VEHICLE/INSPECTIONEG -\$16,494,584 SG RV See NoteEliminates the state inspection sticker requirement for certain vehicles

Present law requires all motor vehicles have an inspection sticker. **Proposed law** modifies present law by requiring only those vehicles required by proposed law have an inspection sticker. **Proposed law** authorizes certain law enforcement agencies to issue citations for motor vehicles that are unsafe or not equipped according to **present law**. **Proposed law** requires only commercial vehicles and student transportation vehicles have an inspection sticker.

Proposed law also requires those vehicles registered in parishes governed by the U.S. Clean Air Act to obtain an emissions inspection as required under federal law. **Proposed law** eliminates the requirement of assembled vehicles to have an inspection sticker. **Proposed law** eliminates law enforcement's ability to require drivers to submit to a vehicle inspection and test. Effective if and when the Act which originated as House Bill No. 601 of the 2019 Regular Session of the Legislature becomes effective.

EXPENDITURE EXPLANATION

Proposed law may create a minimal expenditure impact (approximately \$6,087) to the Department of Public Safety (DPS), Office of Motor Vehicles (OMV) for an IT Applications programmer to make coding changes regarding the sale of emission stickers in OMV's Mapper Business Information Server (BIS) System. This is anticipated to require 80 hours at \$75 per hour including Medicare costs for a total cost of approximately \$6,087 (80 hours x \$75 per hour x 1.45% Medicare). The Legislative Fiscal Office believes that any additional IT work associated with this legislation will be incremental in nature, and that the Department can potentially accomplish these tasks utilizing existing resources and budget authority. To the extent that numerous pieces of legislation are enacted that require additional programming efforts and system modifications, the Department will likely require additional resources.

While **proposed law** does not directly impact other expenditures, \$4.4 M of the revenues collected by OMV are utilized for its general operating expenses. Additionally, approximately \$12.1 M of SGR revenues are currently transferred to the Office of State Police (OSP) for general operations. A reduction of approximately \$16.5 M in SGR revenues may require an offsetting appropriation of SGF to maintain current activity levels or may require a significant SGR expenditure reduction within OMV or (OSP) for unspecified activities.

REVENUE EXPLANATION

Proposed law is anticipated to reduce annual SGR revenues for the Department of Public Safety (DPS), Office of Motor Vehicles (OMV) by approximately \$4.4 M and for DPS Office of State Police (OSP) by approximately \$12.1 M for a total reduction of \$16.5 M. **Proposed law** removes the inspection sticker requirement for all vehicles except for commercial motor vehicles and student transportation vehicles, which will eliminate approximately 95% of the inspection stickers sold each year.

The annual inspection sticker fee is \$10. For each \$10 fee collected, OSP receives \$4, OMV receives \$1.25, and the remaining \$4.75 is retained by the local Motor Vehicle Inspection (MVI) station. OMV also collects an \$8 handling fee per book of inspection stickers sold. Using data from FY 14 - FY 18 to project future fiscal year inspection stickers sales under **present law** (excluding commercial motor vehicles and student transportation vehicles), OMV estimates issuance of approximately 634,000 one-year inspection stickers, 1.2 M two-year inspection stickers, and 71,600 inspection sticker books.

Note: Proposed law is anticipated to significantly reduce the revenues MVI stations receive from inspection stickers by approximately \$14.4 M.

Proposed law is contingent on the passage of HB 601 of 2019, which will increase SGR revenues for the Department of Public Safety (DPS), Office of Motor Vehicles (OMV) by approximately \$4.4 M and for DPS Office of State Police (OSP) by approximately \$30.5 M from a \$10 annual inspection fee at the time of the vehicle's registration or registration renewal. Therefore, the net projected change if both house bills are enacted is (\$14,000) for OMV and \$18.3 M for OSP.
