(ii) Collect a nonrefundable application fee of ten thousand dollars. 26 27 (iii) Receive an amount not to exceed seven percent of the gross sales. 28 Assess a fee of seven percent of the gross sales of therapeutic marijuana that 29 shall be collected by the Department of Revenue and shall be subject to the 30 provisions of Chapter 18 of Subtitle II of Title 47 of the Louisiana Revised 31 Statutes of 1950 as amended. Notwithstanding the provisions of 32 Subparagraph (b) of this Paragraph, the department shall transfer monthly to 33 the state treasury for deposit into the Community and Family Support System 34 Fund, as established in R.S. 28:826, the amount of revenues collected in 35 accordance with this Item. An amount shall be allocated to the department, pursuant to legislative appropriation, for regulatory, administrative, 36 investigative, enforcement, legal, and other such expenses as may be 37 38 necessary to carry out the provisions of this Chapter and for activities
