1 AMENDMENT NO. 1

- 2 On page 1, line 2, delete "R.S. 40:1061.1.3, relative to abortion;" and insert in lieu thereof
- 3 "R.S. 40:1061.1.3 and Part III of Chapter 8 of Title 46 of the Louisiana Revised Statutes of
- 4 1950, to be comprised of R.S. 46:977.21 through 977.25, relative to abortion and infants
- 5 born with disabilities;"
- 6 AMENDMENT NO. 2
- 7 On page 1, line 4, after "effectiveness;" and before "and to" insert "to provide for Medicaid-
- 8 funded health services for children with disabilities;"
- 9 AMENDMENT NO. 3
- On page 1, at the end of line 7, insert a semicolon ";" and "referral for health services"
- 11 AMENDMENT NO. 4
- On page 3, between lines 2 and 3, insert the following:
- "(5) If a fetal heartbeat is detected in an unborn human being pursuant
- to the ultrasound procedure required by Subparagraph (1)(a) of this
- Subsection, then the provider of the ultrasound shall inform the pregnant
- woman that if her child is born with a developmental, intellectual, or physical
- 17 <u>disability, then the child may be eligible for the Medicaid-funded health services</u>
- 18 provided for in R.S. 46:977.21 et seq."
- 19 <u>AMENDMENT NO. 5</u>
- 20 On page 4, between lines 6 and 7, insert the following:
- 21 "Section 2. Part III of Chapter 8 of Title 46 of the Louisiana Revised Statutes of
- 22 1950, comprised of R.S. 46:977.21 through 977.25, is hereby enacted to read as follows:

PART III. SERVICES FOR CHILDREN WITH DISABILITIES - TEFRA OPTION

2	§977.21. Purpose
3	The purpose of this Part is to provide for the TEFRA option within the
4	Medicaid program of this state through which children with disabilities can
5	access Medicaid-funded services regardless of their parents' income.
6	§977.22. Definitions
7	For purposes of this Part, the following terms have the meaning ascribed
8	in this Section:
9	(1) "Department" means the Louisiana Department of Health.
10	(2) "Medicaid" means the medical assistance program provided for in
11	Title XIX of the Social Security Act.
12	(3) "Secretary" means the secretary of the Louisiana Department of
13	Health.
14	(4) "TEFRA option" means the program authorized under section 134
15	of the Tax Equity and Fiscal Responsibility Act of 1982 (P.L. 97-248), and
16	provided for more specifically in this Part, which furnishes Medicaid benefits
17	to children with disabilities who are otherwise ineligible for such benefits
18	because the income of their household exceeds state-established limits for
19	Medicaid eligibility.
20	§977.23. TEFRA option established; application to federal Medicaid agency;
21	limitation
22	A. The legislature hereby creates a TEFRA option program in order to
23	protect and promote public health and well-being in this state. The secretary
24	shall develop and submit to the Centers for Medicare and Medicaid Services a
25	Medicaid state plan amendment in order to implement the TEFRA option
26	program. The department shall establish the eligibility factors and benefits of
27	the TEFRA option program in accordance with the requirements and
28	specifications provided in this Part.
29	B. The TEFRA option shall offer coverage exclusively through the
30	Medicaid fee-for-service system unless the department determines that offering
31	TEFRA option coverage to persons enrolled in the Medicaid managed care
32	program would be more cost-effective.
33	§977.24. Eligibility factors; benefits; premium payment program participation
34	A. In order to be eligible for the TEFRA option, a child shall meet all of
35	the following eligibility criteria:
36	(1) He is a Louisiana resident and United States citizen.
37	(2) He is under the age of nineteen.
38	(3) He has a disability that is recognized under the definition of
39	disability utilized in the Supplemental Security Income program of the Social
40	Security Administration, regardless of whether he is eligible to receive benefits
41	under that program.
42	(4) He is ineligible for Medicaid coverage when the income of his parents
43	is considered.
44	(5) Excluding the assets of his parents, he does not have total assets
45	exceeding two thousand dollars in value.
46	(6) Due to his disability, he requires a level of care provided in a
47	hospital, skilled nursing facility, or intermediate care facility; however, care
48	provided outside of such an institution may be appropriate.
49	(7) The cost of his care provided at his home is less than the cost of
50	institutional care.
51	B. The TEFRA option shall provide to eligible children coverage for all
52	Medicaid state plan services.
53	C. To the maximum extent practicable, as determined by the secretary,
54	the department shall include TEFRA option beneficiaries in its health insurance

1	premium payment program as a means of maximizing private health insurance
2	coverage of Medicaid enrollees.
3	§977.25. Administrative rulemaking
4	The department shall promulgate all such rules in accordance with the
5	Administrative Procedure Act as are necessary to implement the provisions of
6	this Part."
