Prohibits lifetime and annual limits on health insurance benefits

<u>Proposed law</u> requires all health coverage plans issued for delivery, delivered, renewed, or otherwise contracted for after January 1, 2020, to provide coverage without lifetime or annual limits on the dollar amount of benefits for individuals. <u>Proposed law</u> applies only to the following: included among covered benefits of the base-benchmark plan selected for Louisiana for calendar year 2019; or required as a state mandated health benefit pursuant to the LA Insurance Code. <u>Proposed law</u> does not apply to plans meeting the following criteria: if it is an individual plan offered in the individual market; covers only individuals who have been continuously covered by the plan since March 23, 2010; and is a qualified grandfathered health plan pursuant to the Code of Federal Regulations. <u>Proposed law</u> does not apply to limited health benefits. <u>Proposed law</u> does not apply to limited health benefits. <u>Proposed law</u> does not apply to limited health benefit policies. <u>Proposed law</u> clarifies that present law regarding guaranteed renewability of coverage shall only apply if the Patient Protection and Affordable Care Act is repealed or ruled unenforceable. <u>Proposed law</u> defines "health coverage plan."
