PROPERTY/RIGHTS: Provides for ownership in bond for deed contracts for purposes of homestead exemptions

1	AN ACT
2	To amend and reenact Civil Code Article 477 and to repeal R.S. 9:2948, relative to bond for
3	deed contracts; to provide for ownership of property for purposes of the homestead
4	exemption; to repeal unconstitutional law; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. Civil Code Article 477 is hereby amended and reenacted to read as
7	follows:
8	Art. 477. Ownership; content
9	A. Ownership is the right that confers on a person direct, immediate, and
10	exclusive authority over a thing. The owner of a thing may use, enjoy, and dispose
11	of it within the limits and under the conditions established by law.
12	B. A buyer and occupant of a residence under a bond for deed contract is the
13	owner of the thing for purposes of the homestead exemption granted to other
14	property owners pursuant to Article VII, Section 20(A) of the Constitution of
15	Louisiana. The buyer under a bond for deed contract shall apply for the homestead
16	exemption each year.
17	Section 2. R.S. 9:2948 is hereby repealed in its entirety.

Abstract: Repeals unconstitutional laws relative to bond for deed contracts.

<u>Present law</u> (Const. Art. VII, 20(A)(7)) provides that no homestead exemption shall be granted on bond for deed property.

<u>Present law</u> (C.C. Art. 477(B)) provides that the buyer under a bond for deed contract is the owner of the thing for purposes of the homestead exemption.

<u>Proposed law</u> repeals <u>present law</u> (C.C. Art. 477(B)) as unconstitutional in light of Const. Art. VII, §20(A)(7).

<u>Present law</u> (R.S. 9:2948) deems a buyer in a bond for deed contract the owner of the property for purposes of the homestead exemption only.

<u>Proposed law</u> repeals <u>present law</u> (R.S. 9:2948) in light of Const. Art. VII, §20(A)(7) and the court's ruling in *Wooden v. Louisiana Tax Commission*, 650 So. 2d 1157 (La. 1995).
