**Abstract:** Prohibits risks classifications based on an insured's credit information when determining rates.

<u>Present law</u> prohibits inadequate or unfairly discriminatory rates in a competitive market.

<u>Present law</u> prohibits rates from being excessive, inadequate, or unfairly discriminatory in a noncompetitive market.

<u>Present law</u> authorizes risk classifications based on any criteria except race, color, creed, or national origin.

<u>Proposed law</u> retains <u>present law</u> and further prohibits risk classifications based on a person's credit information.

Present law regulates the use of credit information for personal insurance.

Proposed law repeals present law.
