APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of the judgment against the State of Louisiana, DOTD, in "Jean Boudreaux and the Victims of the Flood on April 6, 1983 on the Tangipahoa River v. The State of Louisiana, Department of Transportation, et al"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2020-3 2021 to be used to pay the final judgment in the suit entitled "Jean Boudreaux and 4 the Victims of the Flood on April 6, 1983 on the Tangipahoa River v. The State of 5 Louisiana, Department of Transportation, et al"; to provide for interest; to provide 6 for court costs; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1.The sum of Ninety-One Million Eight Hundred Twenty-Four Thousand 9 Seven Hundred Twenty and 79/100 (\$91,824,720.79) Dollars, plus legal interest from April 10 6, 1984, until paid, is hereby appropriated out of the General Fund of the state of Louisiana 11 for Fiscal Year 2020-2021, which shall be payable to plaintiffs through Hancock Bank, as 12 escrow agent, into escrow account number 1097000229 for payment of the judgment 13 rendered in the class action suit entitled "Jean Boudreaux and the Victims of the Flood on 14 April 6, 1983 on the Tangipahoa River v. The State of Louisiana, Department of Transportation, et al", bearing Number 2004-0985 on the docket of the Louisiana Court of 15 16 Appeal, First Circuit, which appropriation is to be made only after there is a signed 17 agreement of judgment between the class and the state. 18 Section 2. The judgment provided for in Section 1 hereof shall be deemed to have

been paid on the effective date of this Act and legal interest shall cease to run as of that date.
