2 To enact R.S. 33:1236.30, relative to the powers of certain parish governing authorities; to 3 provide relative to work performed by such governing authorities; to authorize the 4 governing authorities to perform such work within the territorial boundaries of 5 certain municipalities located within parish; and to provide for related matters. Be it enacted by the Legislature of Louisiana: 6 7 Section 1. R.S. 33:1236.30 is hereby enacted to read as follows: 8 §1236.30. Certain parishes; perform work within municipal limits 9 Notwithstanding any other provision of law to the contrary, the governing 10 authority of any parish with a population of not less than nineteen thousand persons 11 and not more than twenty thousand five hundred persons according the latest federal 12 decennial census may, upon request of the governing authority of any municipality 13 located within the parish and having a population of not less than three hundred 14 persons and not more than six hundred person according to the latest federal 15 decennial census, perform work on property situated within the jurisdiction of any 16 such municipality including but not limited to the repair, maintenance, and care of 17 roads, streets, alleys, bridges, and culverts and other drainage facilities. The governing authority of any such parish or municipality may enter into an 18 19 intergovernmental agreement to provide for the performance of work authorized by

**Abstract:** Authorizes certain parish governing authorities to perform work, including the repair or maintenance of roads, inside the boundaries of certain municipalities located within the parish, upon the request of the municipal governing authority.

<u>Proposed law</u> authorizes the governing authority of any parish with a population of not less than 19,000 persons and not more than 20,500 persons to perform work inside the boundaries of any municipality located within the parish and having a population of not less than 300 persons and not more than 600 persons, upon the request of the municipal governing authority. Provides that the work may include the repair, maintenance, and care of roads, streets, alleys, bridges, and culverts and other drainage facilities. Authorizes the parishes and municipalities to enter into intergovernmental agreements for the performance of such work.
