9	Section 1. R.S. 33:4574.1.1(F)(5) is hereby amended and reenacted to read as

15	(5)(a) The governing authority of the commission may enter into a
16	cooperative endeavor agreement contract with the governing authority or authorities
17	of the parish or parishes within its territories, or with any public entity authorized to
18	collect sales or use tax, for the collection of the tax which it levies under such terms
19	and conditions it may deem appropriate, including a reasonable collection fee, and

1	may adopt such rules and regulations pursuant thereto regarding the enforcement and
2	collection of the occupancy tax authorized by this Chapter.
3	(b) The commission provided for in R.S. $33:4574(B)(38)$ shall have the right
4	to contract with the state for such collection.
5	(c) The Beauregard Tourist Commission may contract with the parish sheriff
6	for collection of occupancy taxes authorized by this Chapter.

8	Section 2. This Act shall become effective upon signature by the governor or, if not
9	signed by the governor, upon expiration of the time for bills to become law without signature
10	by the governor, as provided in Article III, Section 18 of the Constitution of Louisiana. If
11	vetoed by the governor and subsequently approved by the legislature, this Act shall become
12	effective on the day following such approval.

Abstract: Authorizes the Beauregard Tourist Commission to contract with the parish sheriff for collection of its hotel occupancy taxes.

<u>Present law</u> authorizes parish tourist commissions to levy hotel occupancy taxes. Authorizes a commission to contract with the parish or any public entity authorized to collect sales or use tax for the collection of the tax.

<u>Proposed law</u> authorizes the Beauregard Tourist Commission to contract with the parish sheriff for collection of occupancy taxes.

Effective upon signature of governor or lapse of time for gubernatorial action.
