Requires certain public trusts to obtain approval of a parish or municipal governing authority under certain circumstances prior to undertaking an authorized public function or purpose

Purpose of the Bill: This bill adds a requirement that a public trust which has a Parish, Municipality, or other Political or Governmental Subdivision as its beneficiary, must obtain approval through resolution, from this Parish or Municipal governing authority, prior to carrying out any public function or purpose **outside of the geographic boundaries of this beneficiary**.
