2	To express the condolences of the House of Representatives upon the death, on Sunday,
3	May 17, 2020, of the Honorable Henry Garland Sullivan, Jr. of New Orleans,
4	Louisiana.
5	WHEREAS, the Honorable Henry Garland Sullivan, Jr. was born on September 4,
6	1947, in New Orleans; he graduated from De La Salle High School in New Orleans in 1965,
7	completed a bachelor of science degree at Southeastern Louisiana University in 1969, and
8	received his juris doctorate degree from Loyola Law School in 1974; and
9	WHEREAS, Judge Sullivan's legal career began with twenty-two years in private
10	practice; during that time, he also served as an assistant parish attorney for Jefferson Parish,
11	as a legal advisor to the Jefferson Parish Sheriff's Office, and as an assistant district attorney
12	in Jefferson Parish; and
13	WHEREAS, Judge Sullivan's legal service to the community did not go
14	unrecognized, and in 1996, he was elected as a judge to the Louisiana 24th Judicial District
15	Court; in 2008, he was appointed as Chief Judge of the 24th Judicial District Court; and
16	WHEREAS, Judge Sullivan was highly involved throughout his professional life; he
17	was a member of many associations, including the Jefferson Bar Association, the American
18	Bar Association, the Louisiana State Bar Association, the Louisiana Fourth and Fifth Circuit
19	Judges Association, of which he served as president, and many others; he was also a fellow
20	of the Louisiana Bar Foundation; and
