## COMMENDATIONS: Commends Krispy Kreme Baton Rouge on its reopening and commitment to the community

1	A RESOLUTION
2	To commend Krispy Kreme in Baton Rouge on its reopening and for its commitment to the
3	community.
4	WHEREAS, the Plank Road location of Krispy Kreme in Baton Rouge first opened
5	its doors to the public in 1960; and
6	WHEREAS, Baton Rouge's Krispy Kreme has remained in nearly continuous
7	operation since its opening, closing briefly in the early 2000s for renovations, and most
8	recently, the donut shop closed its doors for almost an entire year as it underwent further
9	renovations; and
10	WHEREAS, despite the uncertainty surrounding the COVID-19 pandemic, Krispy
11	Kreme reopened its drive-thru in Baton Rouge on Tuesday, May 26, 2020; and
12	WHEREAS, under normal circumstances, the store is a continuous twenty-four hour,
13	seven-day-a-week operation with roughly eighty employees; this location regularly serves
14	customers from Lake Charles to Hammond and Brookhaven, Mississippi, to Vacherie; and
15	WHEREAS, Krispy Kreme is heavily involved in the Louisiana community,
16	investing more than five hundred thousand dollars annually in local purchases; in 2001, the
17	store contributed over \$264,000 through its FUNdraising program; this program is a
18	continuous charitable operation undertaken by the chain; and
19	WHEREAS, the former building on Plank Road was razed to make way for a
20	completely new store, and many Louisianians are elated to have the beloved donut shop
21	operating once more in Baton Rouge.

1 THEREFORE, BE IT RESOLVED that the House of Representatives of the 2 Legislature of Louisiana does hereby commend Krispy Kreme on the reopening of its Plank 3 Road location in Baton Rouge; does hereby express appreciation to the store for its service 4 and commitment to the Baton Rouge community; and does hereby extend sincere hopes and

- 5 wishes that the store has success in its future operations.

7 Krispy Kreme on Plank Road in Baton Rouge.
