1 AN ACT

To amend and reenact R.S. 17:407.51(H)(2), to enact R.S. 17:407.23(D)(3), Part X-F of Chapter 1 of Title 17 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 17:407.101, and R.S. 36:651(G)(8), and to repeal R.S. 17:407.23(D)(3), Part X-F of Chapter 1 of Title 17 of the Louisiana Revised Statutes of 1950, comprised of R.S. 17:407.101, and R.S. 36:651(G)(8), relative to the development of early childhood care and education; to establish the Early Childhood Care and Education Commission; to provide relative to the purpose, membership, and meetings of the commission; to require the commission to study and make recommendations relative to specific matters; to require the commission to report to the legislature; to provide for termination of the commission; to provide for the authority and responsibilities of the State Board of Elementary and Secondary Education; to provide for the powers and duties of the Advisory Council on Early Childhood Care and Education; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 17:407.51(H)(2) is hereby amended and reenacted and R.S. 17:407.23(D)(3) and Part X-F of Chapter 1 of Title 17 of the Louisiana Revised Statutes of 1950, comprised of R.S. 17:407.101, are hereby enacted to read as follows:

PART X-F. EARLY CHILDHOOD CARE AND EDUCATION COMMISSION §407.101. Early Childhood Care and Education Commission

A. The legislature finds that the early childhood care and education network established by Act No. 3 of the 2012 Regular Session of the Legislature and community networks created by the State Board of Elementary and Secondary Education have been instrumental in improving kindergarten readiness. Community networks, especially those with the highest performance, are able to demonstrate that affordable access can be achieved when provided with adequate resources. Providing early childhood programming of high quality, rather than affordable access alone, must remain a state priority. While quality can be measured on a statewide basis, it is best assured through community-based plans and local early childhood program collaboration.

1	B. The Early Childhood Care and Education Commission is hereby
2	established for the purpose of building on the foundation established by Act No. 3
3	of the 2012 Regular Session of the Legislature to create a vision for the future of
4	early childhood care and education in Louisiana.
5	C.(1) The commission is composed of forty-one members as follows:
6	(a) One representative of a municipality that receives Head Start funding,
7	appointed by the governor.
8	(b) One representative of a Head Start program, appointed by the governor.
9	(c) One representative of a child advocacy or community organization,
10	appointed by the governor.
11	(d) One representative of a special-needs advocacy organization, appointed
12	by the governor.
13	(e) One representative of the governor's office, appointed by the governor.
14	(f) One business representative, appointed by the speaker of the House of
15	Representatives.
16	(g) One local school superintendent, appointed by the speaker of the House
17	of Representatives.
18	(h) One representative of Type III early learning centers, appointed by the
19	speaker of the House of Representatives.
20	(i) One representative of a child advocacy or community organization,
21	appointed by the speaker of the House of Representatives.
22	(j) One parent of a child in a publicly funded child daycare center, Early
23	Head Start Center, Head Start Center, or stand-alone prekindergarten program,
24	appointed by the speaker of the House of Representatives.
25	(k) Two members of the House of Representatives, appointed by the speaker
26	of the House of Representatives.
27	(1) One business representative, appointed by the president of the Senate.
28	(m) One local school superintendent, appointed by the president of the
29	Senate.

1	(n) One representative of Type III early learning centers, appointed by the
2	president of the Senate.
3	(o) One representative of a child advocacy or community organization,
4	appointed by the president of the Senate.
5	(p) One parent of a child in a publicly funded child daycare center, Early
6	Head Start Center, Head Start Center, or stand-alone prekindergarten program,
7	appointed by the president of the Senate.
8	(q) Two members of the Senate, appointed by the president of the Senate.
9	(r) Two representatives of high-performing community early childhood care
10	and education networks, appointed by the State Board of Elementary and Secondary
11	Education upon recommendation of the state superintendent of education.
12	(s) One representative of a nonpublic school participating in a publicly
13	funded early childhood care and education program, appointed by the State Board
14	of Elementary and Secondary Education.
15	(t) A member appointed by the American Academy of Pediatrics, Louisiana
16	Chapter.
17	(u) One person with professional expertise in the operations of a family care
18	center, appointed by the governor.
19	(v) One early care and education researcher from a public postsecondary
20	education institution, appointed by the speaker of the House of Representatives.
21	(w) One representative from either a Type I or Type II early learning center,
22	appointed by the president of the Senate.
23	(x) One representative of maternal, infant, and early childhood home
24	visitation programs within the Bureau of Family Health, appointed by the secretary
25	of the Louisiana Department of Health.
26	(y) One representative of the Early Steps program within the Bureau of
27	Family Health, appointed by the secretary of the Louisiana Department of Health.
28	(z) One representative of early childhood programs within the state
29	Department of Education, appointed by the state superintendent of education.

1	(aa) One representative of the Louisiana Head Start Collaboration Office,	
2	appointed by the state superintendent of education.	
3	(bb) One representative of the special education programs within the	
4	Department of Education, appointed by the state superintendent of education.	
5	(cc) A staff member of the Board of Regents, appointed by the Board of	
6	Regents.	
7	(dd) The secretary of the Louisiana Workforce Commission, or his designee.	
8	(ee) The secretary of the Department of Economic Development, or his	
9	designee.	
10	(ff) The secretary of the Department of Children and Family Services, or his	
11	designee.	
12	(gg) One professional with expertise in the socioemotional development and	
13	well-being of children from birth through age four, appointed by the governor.	
14	(hh) One early intervention researcher from a Louisiana public	
15	postsecondary education institution, appointed by the Board of Regents.	
16	(ii) One early childhood education researcher from a Louisiana public	
17	postsecondary education institution, appointed by the Board of Regents.	
18	(jj) One member of the State Board of Elementary and Secondary Education,	
19	appointed by the president of the board.	
20	(kk) One early childhood development and education specialist, appointed	
21	by the president of the Center for Development and Learning.	
22	(ll) One member of the Louisiana Educational Television Authority,	
23	appointed by the chairman of the authority.	
24	(2) A vacancy in the membership of the commission shall be filled in the	
25	same manner as the original appointment.	
26	(3) The chairman of the House Committee on Education and chairman of the	
27	Senate Committee on Education, acting jointly, shall select two members to serve	
28	as co-chairmen of the commission.	
29	(4) The members of the commission shall serve without compensation.	

1	D. The state Department of Education shall provide staff support for the
2	commission.
3	E. The commission shall study and make recommendations relative to
4	establishing a vision for the future of early childhood care and education in
5	Louisiana. When conducting analysis and making recommendations relative to a
6	vision and framework, the commission shall do all of the following:
7	(1) Gather and analyze data relative to the current availability, quality, and
8	cost of early childhood care and education throughout the state for children from
9	birth through age four, determine needs and priorities, and develop a plan focused
10	on family access, affordability, and quality.
11	(2) Consider research, local coordination currently established in Louisiana
12	including current high-performing community networks, and related work done in
13	other states to determine best practices for the purpose of informing and fostering the
14	continued development of local governing entities that coordinate across programs
15	and providers in order to meet family needs, drive quality improvement, maximize
16	financial resources, and support children from birth through age four and their
17	<u>families.</u>
18	(3) Determine a sustainable infrastructure to ensure quality programs across
19	providers. Such infrastructure shall include workforce and professional development,
20	monitoring and assessment, coordinated enrollment, and data-informed
21	decisionmaking.
22	(4) Identify opportunities for collaboration and coordination among
23	programs and agencies responsible for development of children from birth through
24	age four.
25	(5) Define a timeframe for achieving the vision and determine benchmarks
26	for the intervening years.
27	(6) Determine the amount of funding needed to achieve affordable access to
28	quality care and education for all children from birth through age four and
29	recommend policies that prioritize the allocation of future funding.

1	(7) Gather and analyze data, laws, and policy in Louisiana and other states	
2	where children are in the care of family child care providers and consider and make	
3	recommendations relative to the incorporation of such providers into the early	
4	childhood care and education network.	
5	(8) Establish and appoint members to a task force to identify and recommend	
6	alternative state and local funding strategies for quality early childhood care and	
7	education. The commission shall incorporate the task force's findings and	
8	recommendations into the report that the commission produces pursuant to	
9	Subsection F of this Section.	
10	(a) The state Department of Education shall provide staff support for the task	
11	force.	
12	(b) The task force shall have the following nine members:	
13	(i) The two co-chairs of the commission, each of whom may designate	
14	someone to serve in his place.	
15	(ii) One representative of the business community.	
16	(iii) One person with significant experience in the generation and	
17	administration of local government revenue.	
18	(iv) One representative of a statewide public policy organization involved	
19	in early childhood issues.	
20	(v) One representative of a statewide foundation or nonprofit organization	
21	involved in early childhood issues.	
22	(vi) One representative of a child advocacy or community organization.	
23	(vii) One representative of a public postsecondary education institution in	
24	Louisiana representing the discipline of economics with experience in the study of	
25	local, state, and regional fiscal policy.	
26	(viii) One parent of a child in a publicly funded childcare center, Early Head	
27	Start Center, Head Start Center, or stand-alone prekindergarten program.	
28	F. Not later than fourteen days prior to the beginning of the 2021 Regular	
29	Session of the Legislature, the commission shall produce a report of its findings and	
30	recommendations. Not later than fourteen days prior to the beginning of the 2022

1	Regular Session of the Legislature, the commission shall produce a report on the		
2	status of the implementation of its recommendations. The reports shall be provided		
3	to the governor, members of the legislature, the state superintendent of education,		
4	and the State Board of Elementary and Secondary Education no less than fourteen		
5	days prior to the first day of the regular session.		
6	G. The commission shall meet at least twice between the 2020 and 2021		
7	Regular Sessions of the Legislature and shall meet at least twice between the 2021		
8	and 2022 Regular Sessions of the Legislature during which meetings the state		
9	Department of Education shall provide updates on how the commission's		
10	recommendations are being implemented. The commission shall make any further		
11	recommendations it deems necessary to advance the vision and goals established.		
12	H. A majority of the members of the commission shall constitute a quorum		
13	for the transaction of business. The commission shall be domiciled in Baton Rouge		
14	but may hold public hearings elsewhere in the state.		
15	Section 2. R.S. 36:651(G)(8) is hereby enacted to read as follows:		
16	§651. Transfer of boards, commissions, departments, and agencies to Department		
17	of Education; boards, commissions, and agencies within Department of

20	G. The following agencies, as defined by R.S. 36:3, are transferred to and		
21	hereafter shall be within the Department of Education as provided in Part III of		
22	Chapter 22 of this Title:

24	(8) The Early Childhood Care and Education Commission (R.S. 17:407.101).

26	Section 3. R.S. 17:407.23(D)(3), Part X-F of Chapter 1 of Title 17 of the Louisiana		
27	Revised Statutes of 1950, comprised of R.S. 17:407.101, and R.S. 36:651(G)(8) are hereby		
28	repealed in their entirety.		
29	Section 4.(A) Sections 1 and 2 and this Section of this Act shall become effective		
30	upon signature of this Act by the governor or, if not signed by the governor, upon expiration		

1	of the time for bills to become law without signature by the governor, as provided by Article		
2	III, Section 18 of the Constitution of Louisiana. If this Act is vetoed by the governor and		
3	subsequently approved by the legislature, Sections 1 and 2 and this Section of this Act shall		
4	become effective on the day following such approval.		
5	(B) Section 3 of this Act shall become effective on July 1, 2022.
