A RESOLUTION

2020, of Amber Stevens.
WHEREAS, Amber Stevens was a resident of Metairie and a longtime volunteer
advocate for the American Cancer Society Cancer Action Network, or ACS CAN; and
WHEREAS, Mrs. Stevens always attended ACS CAN's annual day at the capitol;
during this event, she made sure to capitalize on every opportunity to speak with legislators
about the ACS CAN's state legislative priorities as well as the issues that were most
important to her; Amber was selected as the network's Volunteer of the Year in 2017; and
WHEREAS, Amber's volunteerism and passion for advocacy were motivated by her
belief in the importance of research in the fight against cancer and her dedication to ensuring
