A RESOLUTION

To express the sincere condolences of the Senate of the Legislature of Louisiana upon the death of Dr. Trapper Lee Munn.

WHEREAS, it is with deep regret and profound sorrow that the Senate of the Legislature of Louisiana has learned of the death of Dr. Trapper Lee Munn in a motor vehicle accident on June 21, 2020, at age twenty-eight; and

WHEREAS, Trapper Lee Munn was born on November 1, 1991, in West Monroe, Louisiana, to Milton Lee "Junior" Munn Jr. and Cheral Munn, and resided in New Orleans, Louisiana; and

WHEREAS, he attended Oak Grove High School, graduated from Prairie View Academy in Bastrop, Louisiana, in 2010 and then attended the University of Louisiana Monroe and in 2019, graduated from Louisiana State University Medical School in Shreveport, Louisiana; and

WHEREAS, following medical school, Dr. Munn was accepted into the Urology Program at LSU Health Sciences in New Orleans and was completing his first year of residency; and

WHEREAS, he is survived by his parents, Milton Lee "Junior" Munn Jr. and Cheral (Gregory) Munn; brother and his fiancée, Michael D. Bell and Bonnie Nelson; sister,

12 wherever he went.
