STATE AGENCIES. Requests the Louisiana Board of Pharmacy to study and make recommendations relative to pharmacists' testing, screening, and treatment of certain health conditions.

A RESOLUTION 1 2 To urge and request the Louisiana Board of Pharmacy to study and make recommendations relative to pharmacists' testing, screening, and treatment of certain health conditions. 3 4 WHEREAS, pharmacists are highly educated health care professionals who provide 5 convenient, high-quality health care services, including medication management therapy, immunizations, long-acting injectable medications, disease management, point-of-care 6 7 testing, and patient assessments and screenings to a great number of patients; and 8 WHEREAS, Louisiana pharmacists work in partnership with other health care 9 entities and providers to improve patient outcomes and public health in this state; and 10 WHEREAS, Louisiana law provides for collaborative drug therapy management, the 11 practice in which a pharmacist voluntarily agrees with a physician to manage the disease-specific drug therapy of one or more patients of the physician, within a 12 13 predetermined range of medication selected by the physician and set forth in patient-specific written orders; and 14 WHEREAS, drug therapy management involves monitoring and modifying a 15 16 disease-specific drug therapy; collecting and reviewing patient history; obtaining and reviewing vital signs; ordering, evaluating, and applying the results of laboratory tests 17 directly related to the disease-specific drug therapy being managed under an order; and 18
