AGRICULTURE: Establishes a joint committee to study the feasibility of creating a Louisiana agricultural food commodities day in public schools

1	A CONCURRENT STUDY REQUEST
2	To selected members of the House Committee on Agriculture, Forestry, Aquaculture, and
3	Rural Development, the House Committee on Education, the Senate Committee on
4	Agriculture, Forestry, Aquaculture and Rural Development, and the Senate
5	Committee on Education to meet and to function as a joint committee to study the
6	feasibility of creating a Louisiana agricultural food commodities day in public
7	schools by evaluating the effective utilization of the Louisiana Farm to School
8	Program as found in R.S. 17:195.1, any and all local, state, and federal laws and
9	regulations relative to procuring food for student meals, existing school curriculum
10	and education resources used for the purpose of teaching agricultural literacy lessons
11	in the classroom, and any associated costs and financial impact to state agencies and
12	the state general fund.
13	WHEREAS, the agricultural industry, including forestry, is the number one industry
14	in the state of Louisiana, generating an economic impact of twenty-nine billion three
15	hundred thousand dollars annually to the state's economy; and
16	WHEREAS, the different regions of our state produce a variety of crops and animal
17	products such as rice, sweet potatoes, strawberries, poultry, and crawfish; and
18	WHEREAS, it should be a priority of our elementary and secondary schools to teach
19	and help students to understand where the food on their tables comes from, the jobs available
20	in the agriculture industry, and to generally celebrate Louisiana agriculture; and

1 WHEREAS, one of the best educational methods of teaching students is allowing 2 them to have real-world, tangible experiences to better understand the products and lessons 3 they are learning; and

4 WHEREAS, the Louisiana Farm to School Program was created by Act No. 404 of the 2016 Regular Session of the Legislature to allow schools to partner with local producers 5 6 and use public funds to purchase products to "increase student access to healthy, locally 7 grown fruits, vegetables, and other agricultural products" and to "increase the use of locally 8 grown or raised agricultural products in school nutrition programs"; and

9 WHEREAS, there are community and organizational programs such as Farm 10 Bureau's "Ag in the Classroom", local FFA chapters, and 4-H Club members, which stand 11 ready to assist and support the agricultural literacy needs of school teachers providing 12 lessons through a Louisiana school agricultural food commodities day program.

13 THEREFORE, the Legislature of Louisiana requests the House Committee on 14 Agriculture, Forestry, Aquaculture, and Rural Development, the House Committee on 15 Education, the Senate Committee on Agriculture, Forestry, Aquaculture and Rural 16 Development, and the Senate Committee on Education to meet and to function as a joint 17 committee to study the feasibility of creating a Louisiana agricultural food commodities day 18 in public schools by evaluating the effective utilization of the Louisiana Farm to School 19 Program as found in R.S. 17:195.1, any and all local, state and federal laws and regulations 20 relative to procuring food for student meals, existing school curriculum and education 21 resources used for the purpose of teaching agricultural literacy lessons in the classroom, and 22 any associated costs and financial impact to state agencies and state general fund.

23 THEREFORE, the Legislature of Louisiana requests the chairmen of the House 24 Committee on Agriculture, Forestry, Aquaculture, and Rural Development, the House 25 Committee on Education, the Senate Committee on Agriculture, Forestry, Aquaculture and 26 Rural Development, and the Senate Committee on Education to appoint three members each 27 from their respective committees to participate in the study.

28 THEREFORE, the Legislature of Louisiana further requests the members of the joint 29 committee to elect its chair and vice chair at its initial meeting to be held no later than 30 September 30, 2021.

7	(4) The agricultural centers of Louisiana State University and Southern University
8	and A&M College.
9	(5) The Louisiana Farm Bureau Federation.
10	(6) The Louisiana FFA Association.
11	(7) Louisiana 4-H.
12	(8) The Louisiana legislative fiscal office.
13	THEREFORE, the Legislature of Louisiana requests that the joint committee submit
14	a report of its findings to the legislature sixty days prior to the convening of the 2022
15	Regular Session.
16	THEREFORE, the Legislature of Louisiana further requests that a copy of this study
17	request be sent to the Louisiana Department of Agriculture and Forestry, the Louisiana
18	Department of Education, the Louisiana Board of Elementary and Secondary Education, the
19	agricultural centers of Louisiana State University and Southern University and A&M
20	College, the Louisiana Farm Bureau Federation, the Louisiana FFA Association, Louisiana
21	4-H, and the Louisiana legislative fiscal office.
