INSURANCE POLICIES. Provides for automobile insurance coverage for transportation network drivers. (8/1/21)

2	To amend and reenact R.S. 22:1266(A)(1)(a), relative to automobile insurance policies; to
3	define an automobile insurance policy; to provide for coverage when an insured is
4	logged on to a transportation network company; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 22:1266(A)(1)(a) is hereby amended and reenacted to read as follows:
7	§1266. Automobile, property, casualty, and liability insurance policies; cancellations
8	A. As used in this Part:
9	(1) "Policy" means an automobile liability, automobile physical damage, or
10	automobile collision policy, or any combination thereof, delivered or issued for
11	delivery in this state, or any binder based on such a policy, insuring a single
12	individual or husband and wife resident of the same household, as named insured,
13	and under which the insured vehicles therein designated are of the following types
14	only:
15	(a) A private passenger vehicle that is not used as a public or livery
16	conveyance for passengers, except while the insured is logged on to a
17	transportation network company's digital network during the pre-trip

acceptance period, nor rented to others.

<u>Present law</u>, relative to automobile, property, casualty, and liability insurance policies, defines "policy" as an automobile liability, automobile physical damage, or automobile collision policy, or any combination thereof, delivered or issued for delivery in this state, or any binder based on such a policy, insuring a single individual or husband and wife resident of the same household, as named insured, and under which the insured vehicles are of certain enumerated types.

<u>Present law</u> provides for private passenger vehicles that are not used as a public or livery conveyance for passengers, nor rented to others.

<u>Proposed law</u> provides an exception for private passenger vehicles while the insured is logged on to a transportation network company's digital network during the pre-trip acceptance period.

Effective August 1, 2021.

- 1. Removes provisions regarding uninsured motorist coverage.
- 2. Adds provisions for private passenger vehicles while the insured is logged on to a transportation network company's digital network during the pre-trip acceptance period.
