Amendments proposed by House Committee on Health and Welfare to Original House Bill No. 531 by Representative Pressly

AMENDMENT NO. 1

On page 1, at the end of line 2, insert "3561(A),"

AMENDMENT NO. 2

On page 1, at the beginning of line 3, delete "and 3562(A)(2) and (3), to enact" and insert in lieu thereof "and 3562(A)(1) through (3), to enact R.S. 15:587(A)(1)(k) and"

AMENDMENT NO. 3

On page 1, at the beginning of line 4, delete "3561(A)(1),"

AMENDMENT NO. 4

On page 1, line 8, delete "backgrounds of" and insert in lieu thereof "background checks on"

AMENDMENT NO. 5

On page 1, between lines 17 and 18, insert the following:

"Section 1. R.S. 15:587(A)(1)(k) is hereby enacted to read as follows:

§587. Duty to provide information; processing fees; Louisiana Bureau of Criminal Identification and Information

A.(1)

* * *

(k) The Louisiana Board of Massage Therapy shall submit fingerprint cards and other identifying information of persons seeking licensure pursuant to R.S. 37:3551 et seq. to the bureau. The bureau shall, upon request and after receipt of fingerprint cards and other identifying information from the Louisiana Board of Massage Therapy, make available to the Louisiana Board of Massage Therapy all conviction information contained in the bureau's criminal history record and identification files which pertain to the person seeking licensure with the Louisiana Board of Massage Therapy. In addition, the fingerprints shall be forwarded by the bureau to the Federal Bureau of Investigation for a national criminal history record check.

4 possible by the hands" and after "ultrasound" and before the comma ",," delete "therapy"

5 AMENDMENT NO. 9

6 On page 2, line 21, delete "or" and delete the period "." and insert in lieu thereof a comma
7 ",," and "the use of electrical muscle stimulation, or transcutaneous electrical nerve
8 stimulation except micro current."

9 AMENDMENT NO. 10

10 On page 3, line 5, delete "or certified"

11 AMENDMENT NO. 11

12 On page 3, line 12, after the period "." delete the remainder of the line and delete lines 13
13 and 14 in their entirety and insert in lieu thereof the following:

14 "The Board shall initiate promulgation of such rules and regulations within one
15 hundred twenty days following any new changes to provisions of this Chapter."

16 AMENDMENT NO. 12

17 On page 3, delete lines 19 and 20 in their entirety and insert in lieu thereof the following:

18 "(7) Utilize all legally available news outlets as resources to identify
19 unauthorized activity of a massage therapist or establishment."

20 AMENDMENT NO. 13

21 On page 3, line 21, delete "Monitor" and insert in lieu thereof "Evaluate"

22 AMENDMENT NO. 14

23 On page 3, delete lines 23 and 24 in their entirety and insert in lieu thereof the following:

24 "(9) Include in the inspection protocol a list of observations for inspectors
25 to determine whether there is a strong possibility that an establishment is operating
26 as a sexually-oriented business and forward to law enforcement, if appropriate."

27 AMENDMENT NO. 15

28 On page 4, delete lines 4 through 15 in their entirety and insert in lieu thereof the following:

29 "(14)(a) Submit the names of new applicants for licensure to the Louisiana
30 Bureau of Criminal Identification and Information, located within the Department
31 of Public Safety and Corrections, for criminal history background checks. Upon the
32 board's submission of an applicant's fingerprints and such other identifying
33 information as may be required, the Louisiana Bureau of Criminal Identification and
34 Information shall survey its criminal history record and identification files and shall
35 make available to the board all conviction information contained in the Louisiana
36 Bureau of Criminal Identification and Information's criminal history record and
37 identification files which pertain to the applicant for licensure. In addition, the
38 fingerprints shall be forwarded by the Louisiana Bureau of Criminal Identification
39 and Information to the Federal Bureau of Investigation for a national criminal history
40 record check.

1 **(b) The costs of providing the information required pursuant to this Section**
2 **shall be charged by the Louisiana Bureau of Criminal Identification, as specified in**
3 **R.S. 15:587(B), to the board for furnishing the information contained in the**
4 **Louisiana Bureau of Criminal Identification and Information's criminal history**
5 **record and identification files, including any additional costs of providing the**
6 **national criminal history records checks, which pertains to the applicant for**
7 **licensure.**"

8 AMENDMENT NO. 16

9 On page 5, line 13, after "deliver" and before "a license" insert a comma "," and "by United
10 States Postal Service or any other nonelectronic delivery option."

11 AMENDMENT NO. 17

12 On page 5, delete lines 22 and 23 in their entirety and insert in lieu thereof the following:

13 "A.(1) Each license shall be renewed annually, on or before its expiration
14 date by submitting a renewal application form, payment of the renewal fee specified
15 in R.S. 37:3562, and providing evidence that the licensee has completed continuing
16 education requirements, as established by rule of the board."

17 AMENDMENT NO. 18

18 On page 5, at the beginning of line 24, change "(1)" to "(2)(a)"

19 AMENDMENT NO. 19

20 On page 5, between lines 26 and 27, insert the following:

21 "(b) In the renewal cycle beginning April 1, 2022, and in this cycle only,
22 each renewing applicant shall submit to a background check as described in R.S.
23 37:3555(A)(14). In order to renew, an applicant must not have pled guilty to or been
24 convicted of any sex-related crime, crime of violence, or crime related to the practice
25 of massage therapy."

26 AMENDMENT NO. 20

27 On page 6, delete line 4 and insert the following:

28 "(1) Application fee \$~~75.00~~ 100.00"

37 a disciplinary hearing."
