If 11 vetoed by the governor and subsequently approved by the legislature, this Act shall become 12 effective on the day following such approval.

- (2) Andre' Dugas
- (3) Savanna Broussard Guilbeau
- (4) Clinton J. and Katy J. Angelle
- (5) Lewis O. Bordelon
- (6) Marvin D. France
- (7) Warren Lockridge and Janice Harris

Effective upon signature of governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Natural Resources and Environment</u> to the <u>original</u> bill:

- 1. Authorize the state to transfer an additional tract of land in St. Martin Parish to Andre' Dugas.
- 2. Remove authority for the state to transfer certain property located in St. Martin Parish to Marco Guilbeau.
