To enact R.S. 13:5722(A)(2)(f), relative to court costs in certain parishes; to provide for an 2 3 additional court fee in criminal matters in all courts in certain parishes; to provide 4 relative to the coroner's operational fund; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. Coroner's Operational Fund established 8 A. 9 10 (2) 11 12 (f) Notwithstanding the provisions of R.S. 13:62, in criminal cases, including 13 traffic violations, in all courts in Tensas Parish, East Carroll Parish, and Madison Parish, a fee of not less than five dollars nor more than ten dollars may be imposed 14 15 on every defendant who is convicted after trial or plea of guilty, which fee shall be 16 used solely to defray the operational costs of the office of the coroner of the parish. 17

Abstract: Allows certain parish courts to collect a fee of not less than \$5 nor more than \$10 in criminal cases to be used solely to defray the costs of the office of the coroner of the parish.

<u>Present law</u> establishes the Coroner's Operational Fund and a criminal court fee on certain defendants dedicated to defraying the operational costs of the office of the coroner in the parish in which the conviction occurred. Provides for an additional fee in certain parishes for the support of the coroner.

<u>Proposed law</u> authorizes an additional fee of not less than \$5 and no more than \$10 on every defendant who is convicted in all courts in Tensas Parish, East Carroll Parish, and Madison Parish to be used solely to defray the operational costs of the coroner's office.
