2	To express the sincere condolences of the Legislature of Louisiana upon the passing of the
3	Honorable Victor "Vic" Stelly and Mrs. Terry Bass Stelly and to commend the
4	legacy of public service that they leave to the community of Lake Charles and the
5	state of Louisiana.
6	WHEREAS, it is with great sadness that the Legislature of Louisiana has learned of
7	the death of Mr. and Mrs. Victor Stelly, who passed away within hours from one another due
8	to complications from COVID-19; and
9	WHEREAS, married for over sixty years, Vic and Terry's love affair and great
10	affection for one another was surpassed only by their love for God; and
11	WHEREAS, Vic and Terry's personalities were as different as night and day, but it
12	was their differences that kept them young and passionate; they complemented one another
13	in such a way that, no matter what life threw at them, they were able to lift the other's chin,
14	calm each other's spirit, and continuously pointed one another to what mattered most: family,
15	relationships, and service; and
16	WHEREAS, the Stellys met at Northwestern State University where Vic was a
17	quarterback for the NSU Demons, and inseparable from the day they met, they married
18	during Vic's sophomore year of college; and

1	WHEREAS, upon graduation, the young couple moved to Baton Rouge where Vic
2	attended graduate school at Louisiana State University and began his teaching and coaching
3	career at Broadmoor High School and then at Redemptorist High School before returning
4	to collegiate competition as an assistant coach for McNeese State University; and
5	WHEREAS, as they settled into their new life in the Lake Charles area, Terry began
6	her career in public service as a legal assistant for the office of the district attorney in
7	Calcasieu Parish; and
8	WHEREAS, Vic's last football season at McNeese State University gave way to an
9	entirely new season when he was recruited by State Farm to become the local agent for Moss
10	Bluff, a position he enjoyed for twenty-five years; and
11	WHEREAS, throughout their careers, Vic and Terry had a genuine interest and love
12	for the people they served, they tirelessly invested in their community and church, and they
13	were always open to change that often, but not always, brought growth and opportunity into
14	their lives; and
15	WHEREAS, Vic Stelly answered the call to public service by holding both local and
16	state offices; he was a member of the Calcasieu Parish School Board and a member of the
17	Louisiana House of Representatives; and
18	WHEREAS, he served on the school board from 1983 through 1987 and did not seek
19	reelection because he stated: "I felt like I had done what the people had asked me to do, to
20	get our schools in good shape"; and
21	WHEREAS, with no plans to run for another elected office, Vic Stelly began fielding
22	numerous requests to then become the next state representative for District 35, and without
23	hesitation, he entered the race and won and spent the next sixteen years in Baton Rouge
24	crafting policies with the people's best interest at heart; and
25	WHEREAS, he served with unwavering dedication as a member of the Louisiana
26	House of Representatives from 1988 through 2004 representing the concerns of residents of
27	District 35; and
28	WHEREAS, noted as one of his biggest and most impressive political victories
29	during his tenure, Mr. Stelly's desire to create more fiscal stability for the state by swapping
30	higher income taxes for sales taxes on food, prescription drugs, and utilities was approved

- 2 WHEREAS, Vic Stelly is remembered by his colleagues in the House of 3 Representatives as a fine gentleman and a true statesman and as a man of great character and 4 integrity who led by example and was committed and dedicated to his community; and

5 WHEREAS, throughout her husband's long career in public service, Terry Stelly was 6 with her husband every step of the way, from traveling across the state to gain support for 7 the Stelly Plan, to accompanying Vic to his induction ceremony into the Louisiana Political 8 Hall of Fame in 2006, and to being with him when he returned to Baton Rouge to serve as 9 a member of the Louisiana Board of Regents from 2007 through 2013; and

WHEREAS, while the Stellys were committed and hard-working in everything they did, they also took great pleasure in traveling to their favorite vacation spots, making beautiful memories in Orange Beach, Alabama, with their loved ones, and hosting their family and friends at every opportunity; and

WHEREAS, when they were together, Vic and Terry Stelly were truly their best selves, and together, they brought cohesion and peace to their family and loved their children, grandchildren, and great-grandchildren without limits; and

WHEREAS, Vic and Terry Stelly leave to cherish a lifetime of memories of love,
wisdom, wit, hard work, and humor to their children, Tracy (Mickey) Fendley, Victor Todd
(Lori) Stelly, Toni Stelly Hebert; grandchildren, Lance (Jamie) Fendley, Hannah (Jonathan)
Johnson, Hayden Stelly, Hogan Stelly, Henry Stelly, and Emma Hebert; and
great-grandchildren, Hudson and Truett Fendley and Faith and Lyn Johnson; and

WHEREAS, the passing of Vic and Terry Stelly has left a substantial void in the state of Louisiana and a sense of loss in the people whose lives they touched, and their memory will live forever in the hearts of all those who knew and loved this truly wonderful couple.
