EMPLOYMENT: Provides for vaccine requirements in the workplace

2	To enact Part III of Chapter 3 of Title 23 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 23:271, relative to employment; to provide for COVID-19 vaccine
4	requirements; to provide for a waiver; to provide the means for an employee to be
5	tested; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. Part III of Chapter 3 of Title 23 of the Louisiana Revised Statutes of 1950,
8	comprised of R.S. 23:271, is hereby enacted to read as follows:
9	PART III. VACCINATIONS IN THE WORKPLACE
10	§271. Vaccine requirements in the workplace; COVID-19; exemption
11	A. If an employer who enforces a COVID-19 vaccine requirement waives
12	the requirement for an employee who agrees to submit to regular or periodic testing,
13	the employer shall provide testing options at the place of employment at no cost to
14	the employee.
15	B.(1) In lieu of testing at the place of employment, the employee may
16	provide test results obtained through a licensed healthcare provider or self-
17	administered United States Food and Drug Administration approved test.
18	(2) If the testing is not covered by the employee's insurance or the employee
19	is uninsured, the employer shall cover the cost of testing.

Abstract: Provides that if an employer allows an employee to get regularly or periodically tested for COVID-19 in lieu of the employee adhering to an employer mandated COVID-19 vaccine requirement, then the employer must cover the testing.

<u>Proposed law provides</u> that if an employer, who enforces a COVID-19 vaccine requirement, waives the requirement for an employee, who agrees to submit to regular or periodic testing, the employer shall provide testing options to the employee and cover the cost of testing.

<u>Proposed law</u> provides that the employee, if he so chooses, may provide to the employer, test results from a licensed healthcare provider of his choosing or from a self-administered federally approved COVID-19 test. <u>Proposed law</u> further provides that if the testing is not covered by the employee's insurance or the employee is uninsured, the employer shall cover the cost.
