SECONDHAND DEALERS: Provides relative to the purchase of used catalytic converters

AN ACT

2	To enact Part II-B of Chapter 21 of Title 37 of the Louisiana Revised Statutes of 1950, to
3	be comprised of R.S. 37:1891 through 1896, relative to the purchase of used catalytic
4	converters; to provide definitions; to provide recording requirements; to require
5	payment by check; to require a statement by the seller; to provide for record keeping;
6	to prohibit the purchase of stolen goods; to provide for violations and penalties; and
7	to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Part II-B of Chapter 21 of Title 37 of the Louisiana Revised Statutes of
0	1950, comprised of R.S. 37:1891 through 1896, is hereby enacted to read as follows:
1	PART II-B. USED CATALYTIC CONVERTERS
12	§1891. Definitions
13	For purposes of this Part, the following words have the following meanings:
4	(1) "Catalytic converter" means an exhaust emission control device that
15	reduces toxic gas and pollutants from internal combustion engines.
16	(2) "Person" includes any corporation, limited liability company, partnership,
17	or two or more persons have a joint or common interest.
18	§1892. Recording requirements
19	Any person who purchases a used catalytic converter shall comply with all
20	requirements set forth in R.S. 37:1864 and 1864.1.

2	No person shall enter into any cash transaction for the purchase or sale of a
3	used catalytic converter. Payment for a used catalytic converter shall be made only
4	by check, and the purchaser shall comply with the requirements set forth in R.S.
5	<u>37:1864.3.</u>
6	§1894. Statement by seller required; record keeping
7	Any person who purchases a used catalytic converter shall obtain a signed
8	statement from the seller, and shall comply with the requirements of R.S. 37:1864.4
9	<u>through 1866.</u>
10	§1895. Purchase forbidden
11	No person shall willfully or knowingly purchase a used catalytic converter
12	unpaid for by the seller, or not owned by the seller.
13	§1896. Violations; penalties
14	Any person who violates, neglects, or refuses to comply with any provision
15	of this Part shall be subject to the penalties provided in R.S. 37:1869.

**Abstract:** Regulates the purchase of used catalytic converters.

Present law provides a regulatory structure for secondhand dealers which serves to protect consumers and reduce the sale of stolen goods. Proposed law retains present law.

<u>Present law</u> requires a secondhand dealer to comply with rules relative to the following:

- (1) Recording requirements for purchases.
- (2) A prohibition on cash transactions for certain items.
- Required statement from the seller. (3)
- (4) A prohibition on purchasing stolen goods.

<u>Proposed law</u> retains <u>present law</u> and expands the application of <u>present law</u> to apply the same regulatory requirements to any person who purchases a used catalytic converter.
