FUNDS/FUNDING: Establishes the La. Family and Medical Leave Fund in the state treasury for implementation costs associated with a state-funded family and medical leave program

AN ACT

2 To enact Subpart Q-4 of Part II-A of Chapter 1 of Title 39 of the Louisiana Revised Statutes 3 of 1950, to be comprised of R.S. 39:100.125, relative to the Louisiana Family and 4 Medical Leave Fund; to establish such fund; to deposit monies into the fund; to 5 provide relative to monies in the fund; to provide relative to the powers and duties 6 of the state treasurer; to provide for termination of the fund; to provide for an 7 effective date; and to provide for related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. Subpart Q-4 of Part II-A of Chapter 1 of Title 39 of the Louisiana Revised 10 Statutes of 1950, comprised of R.S. 39:100.125 is hereby enacted to read as follows: 11 SUBPART Q-4. LOUISIANA FAMILY AND MEDICAL LEAVE FUND 12 §100.125. Louisiana Family and Medical Leave Fund; creation 13 A. There is hereby established in the state treasury as a special fund the 14 Louisiana Family and Medical Leave Fund, hereafter referred to in this Section as 15 the fund. After compliance with the requirements of Article VII, Section 9(B) of the 16 Constitution of Louisiana relative to the Bond Security and Redemption Fund, the 17 treasurer is hereby authorized and directed to transfer from the Louisiana Rescue 18 Plan Fund and deposit into the Louisiana Family and Medical Leave Fund an amount 19 equal to twenty million dollars. Monies in the fund shall be invested in the same

manner as monies in the state general fund. Interest earned on investment of monies in the fund shall be credited to the fund. Until December 1, 2024, unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund. The treasurer is hereby authorized and directed to transfer any unexpended and unencumbered monies in the fund on December 1, 2024, and any interest attributable to such funds, to the Louisiana Rescue Plan Fund. Monies in the fund shall be used solely to finance implementation and execution of a state-funded program for family and medical leave. B. The provisions of this Section shall terminate on December 31, 2026. Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become 14 effective on the day following such approval.

Abstract: Establishes the La. Family and Medical Leave Fund (fund) in the state treasury.

Proposed law establishes the fund as a special fund in the state treasury and directs the state treasurer to deposit \$20,000,000 of federal funds from the American Rescue Plan Act into the fund. Requires monies in the fund to be invested in the same manner as monies in the state general fund. Requires interest earned on investment of fund monies to be deposited into the fund. Provides that until Dec. 1, 2024, unexpended and unencumbered monies in the fund must remain in the fund. Directs the state treasurer to transfer any unexpended and unencumbered monies in the fund on December 1, 2024, and any interest attributable thereto, to the La. Rescue Plan Fund. Requires all monies in the fund to be used solely to finance implementation and execution of a state-funded program for family and medical leave.

Proposed law terminates on Dec. 31, 2026.

Effective upon signature of governor or lapse of time for gubernatorial action.
