the state. (8/1/22)

<u>Proposed law</u> requires the office of risk management to confirm or deny coverage of any insurance or related coverage document issued upon request of an agency, department, or claimant. <u>Proposed law</u> authorizes an agency, department, or claimant to request written reasons for a denial of coverage by the office of risk management. <u>Proposed law</u> requires the office of risk management to provide the written reasons for a denial of coverage within 30 days of the request. <u>Proposed law</u> effective August 1, 2022.

EXPENDITURE EXPLANATION

Proposed law may potentially create additional administrative workload expenditures within the Division of Administration, Office of Risk Management (ORM) as a result of responding to request regarding coverage. The proposed law requires ORM to confirm or deny coverage of any insurance claim upon the request of an agency, department, or claimant. In the event of a claim denial, the proposed law allows the agency, department, or claimant to request a written reason for the denial and requires ORM to respond within 30 days of the request. To the extent this propose law results in numerous request for written reasons, ORM may experience an increase in administrative workload to review and coordinate written responses.

The Attorney General/Department of Justice (DOJ) reports there is no impact on department under this measure.
