- Section or submits inaccurate information, may be ineligible to participate in, or receive any funding from, any state-administered grant program
- designated for broadband infrastructure deployment in the state in the
- calendar year of noncompliance and the following calendar year.
- 38 (3) Any location in the state purportedly served by any entity, public
- or private, providing internet service to at least one location in the state, that

1	does not comply with the requirements of this Section may be considered to
2	have internet access service of less than twenty-five megabits per second for
3	download and three megabits per second for upload.
4	B. Information compiled pursuant to the provisions of this Section
5	shall be exempt from the Public Records Law and shall be considered
6	confidential, proprietary and a trade secret of the internet service provider
7	providing the information.
