Provides relative to learning pods established by charter schools

Proposed legislation allows Type 2 charter schools to establish a learning pod at any site selected by the charter school. Provides that the charter school governing authority must notify its authorizer within thirty days of establishing the learning pod. Provides that the learning pod may not be established in any school district that received a letter grade of "A" or "B" for the most recent year pursuant to the district accountability system.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

In March 2022, the Board of Elementary and Secondary Education (BESE) considered and deferred a proposed rule change to policy Bulletin 126 would have required a material amendment to BESE-authorized charters in order to allow the establishment of learning pods. The proposed legislation clarifies that learning pods in Type 2 charter schools do not require a material amendment to a school's charter. Instead, they will be required to notify BESE within thirty days of establishing the learning pod.
