PROPERTY/SUBSTANDARD: Provides relative to nuisance ordinances regarding grass cutting in West Baton Rouge Parish

2	To amend and reenact R.S. 33:1236.26(A), relative to the governing authority of West Baton
3	Rouge Parish; to provide for nuisance ordinances regarding grass and obnoxious

8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 33:1236.26(A) is hereby amended and reenacted to read as follows:
10	§1236.26. Powers of the governing authorities of Pointe Coupee Parish, St. Charles
11	Parish, St. John the Baptist Parish, and St. Landry Parish, and West Baton
12	Rouge Parish; nuisance ordinance regarding grass and obnoxious weeds;
13	notice required
14	A. The governing authorities of the parishes of Pointe Coupee, St. Charles,
15	St. John the Baptist, and St. Landry, and West Baton Rouge may amend ordinances
16	to compel property owners to cut grass and obnoxious weeds on their property
17	without the notice required in R.S. 33:1236(21)(a)(i) if the property owner liable has
18	been notified pursuant to that Item at any time during the immediately preceding
19	twelve months and has failed to do the work himself after an opportunity to do so.

Abstract: Authorizes W. Baton Rouge Parish to take certain actions regarding maintenance of private property.

<u>Present law</u> authorizes parish governing authorities to require property owners to cut grass on their property. If a property owner does not comply with such a requirement, <u>present law</u> requires a parish to request that a property owner cut grass on his property by sending a registered or certified letter. Authorizes a parish to have such work done and charge the property owner for the work if the property owner does not cut the grass within 15 days after receipt of the letter.

Proposed law retains present law.

<u>Present law</u> authorizes specified parishes to proceed with having grass cutting work done and charging the property owner for one year after a single registered or certified letter requesting that the property owner cut his grass. Requires such parishes to file an affidavit that includes:

- (1) A description of the property.
- (2) A photograph of the property identifying the unsafe conditions.
- (3) A statement that the property owner liable has within the past 12 months failed to do such work after notification and an opportunity to do so.

<u>Proposed law</u> adds W. Baton Rouge Parish to parishes authorized to cut grass and charge the property owner for a year after a single request and filing the required affidavit.
