(a) A mixture or substance containing a detectable amount of fentanyl or its analogues, or carfentanil, or a mixture or substance containing a detectable amount of carfentanil, or a mixture or substance containing a detectable amount of carfentanil or its analogues, as provided by R.S. 40:967. It shall not include any substance obtained directly or pursuant to a valid prescription or order from a practitioner, as provided in R.S. 40:978, while acting in the course of the practitioner's professional practice.

36 (b) A mixture or substance containing a detectable amount of fentanyl precursor agents, licit or illicit, that can be used in the production of fentanyl."

- (c) Any activity by a foreign state, directly or through an agent, to facilitate 16 or allow by silent acquiescence or otherwise the placement of licit or illicit fentanyl 17 18 precursor agents into the stream of commerce under circumstances whereby the 19 fentanyl precursor agents are likely to be manufactured into illicit fentanyl and transported into the United States or this state."
