"C. To qualify for a concealed handgun permit, a Louisiana resident shall:

26 (8) Not chronically and habitually use alcoholic beverages to the extent that 27 his normal faculties are impaired. It shall be presumed that an applicant or permittee 28 chronically and habitually uses alcoholic beverages to the extent that his normal 29 faculties are impaired if the applicant has been found guilty of, or entered a plea of 30 guilty or nolo contendere to operating a vehicle while intoxicated, or has been admitted, either voluntarily or involuntarily, for treatment as an alcoholic, within the 31 32 five-year period immediately preceding the date on which the application is 33 submitted, or at any time after the application has been submitted. 34

1	(2) The deputy secretary of public safety services of the Department of
2	Public Safety and Corrections shall issue timely and without delay the concealed
3	handgun permit to all qualified applicants, which permit shall be for a term of five

5	parishes statewide. The division may promulgate rules for the purpose of providing
6	for permits and fees for fewer than five years to the applicants requesting a shorter
7	time period. Fees may be reduced proportionately for terms of fewer than five years.

9	the request of any law enforcement officer.

18	(7) An applicant for a lifetime concealed handgun permit shall pay the yearly
19	fee provided for in Paragraph (II)(2) of this Section but shall prepay that fee for a
20	total of twenty years at the time the application is made a fee of one hundred twenty-
21	five dollars. If the applicant is sixty-five years of age or older, he shall pay the yearly
22	fee provided for in Paragraph (II)(2) of this Section but shall prepay that fee for a
23	total of ten years at the time the application is made a fee of sixty-two dollars and
24	fifty cents.
25	W.(1) Notwithstanding any provision of law to the contrary, an active duty
26	member or reserve member of the armed forces of the United States shall pay one
27	half of the annual fee provided for in Paragraph $(H)(2)$ of this Section for a five-year
28	permit, or if applying for a lifetime concealed handgun permit, he shall prepay that
29	fee for a total of ten years pay a fee of sixty-two dollars and fifty cents at the time the
30	application for the lifetime concealed handgun permit is made.
