To amend and reenact R.S. 40:2009.25(C)(9), (D)(9), and (E)(10), relative to nursing homes
licensed by the Louisiana Department of Health; to provide requirements and
standards for nursing home emergency preparedness plans; to authorize the
Louisiana Department of Health to take certain actions relative to nursing homes;
and to provide for related matters.
Be it enacted by the Legislature of Louisiana:
Section 1. R.S. 40:2009.25(C)(9), (D)(9), and (E)(10) are hereby amended and
reenacted to read as follows:
§2009.25. Emergency preparedness plans for nursing homes; requirements; Nursing
Home Emergency Preparedness Review Committee; rules and regulations

(9) Upon receipt of a nursing home's updated and revised emergency
preparedness plan, the department shall confirm that all required changes,
amendments, or revisions have been incorporated into the updated and revised
emergency preparedness plan, and shall approve the emergency preparedness plan
and issue an approval letter to the nursing home. If the required changes,
amendments, or revisions have not been incorporated, the department shall reject the
emergency preparedness plan and issue a letter of rejection to the nursing home. The

If the required changes, 11 amendments, or revisions have not been incorporated, the department shall reject the 12 emergency preparedness plan and issue a letter of rejection to the nursing home. 19 (10) Upon receipt of a nursing home's updated and revised emergency 20 preparedness plan, the department shall confirm that all required changes, 21 amendments, or revisions have been incorporated into the updated and revised 22 emergency preparedness plan, and shall approve the emergency preparedness plan 23 and issue an approval letter to the nursing home. If the required changes, 24 amendments, or revisions have not been incorporated, the department shall reject the 25 emergency preparedness plan and issue a letter of rejection to the nursing home. The 26 department shall issue the approval letter or rejection letter required by this 27 Paragraph on or before May fifteenth. The department shall not issue a license to or 28 renew a license of a nursing home that has received a letter of rejection of its 29 emergency preparedness plan. The department shall not issue a license to or renew
