SUPPLEMENTAL PAY EG NO IMPACT See Note Provides relative to supplemental pay for municipal or parish fire department employees

<u>Proposed law</u> requires makes the following changes: (1) removes the minimum compensation amount of \$300 regular pay before a fireman can receive supplemental pay; (2) adds the fire chief of a municipality/parish as the party to approve and certify warrants for monthly payments; (3) transfers responsibility for disbursement of payment to the Department of Correction and Public Safety, Public Safety Services (DPS); (4) authorizes DPS to issue payment by agreed upon means without certain statements; (5) makes the fire chief responsible for tax withholdings and retirement calculations; (6) requires DPS to issue daily per diems to each member of the Fireman's Supplemental Pay Board who attend meetings; and (7) removes the requirement that the Fireman's Supplemental Pay Board has an accountant. <u>Proposed law</u> effective 7/01/23.
