FIRE PROTECT/FIREMEN: Provides relative to cancer screenings for certain firefighters and fire service employees

AN ACT

2 To enact R.S. 33:2581.4, relative to certain firefighters and fire service employees; to 3 provide relative to cancer screenings for such firefighters and employees; to provide 4 relative to the time period for cancer screening examinations; to provide relative to 5 screenings for retired firefighters and fire service employees; to provide for an 6 effective date; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. R.S. 33:2581.4 is hereby enacted to read as follows: 9 §2581.4. Cancer screenings; certain firefighters and fire service employees 10 A. A classified firefighter employed as a full-time paid employee of a 11 municipal or parish fire department or fire protection district; fire service employees 12 employed by a non profit corporation under contract with a fire protection district; 13 and volunteer firefighters as defined in R.S. 23:1036 shall be provided a cancer 14 screening examination conducted by a physician not less than three years after the 15 start of employment or volunteer service and every three years thereafter during the course of employment or service. The examination shall include but not be limited 16 to screening for the following cancers: 17 18 (1) Colon. 19 (2) Lung. 20 (3) Bladder.

No co payment, deductible, coinsurance, or any out-of-pocket 16 expense shall be required for such examinations. 17 D. No firefighter or fire service employee shall be required to participate in 18 cancer screening examinations. 19 Section 2. This Act shall become effective upon signature by the governor or, if not 20 signed by the governor, upon expiration of the time for bills to become law without signature 21 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 22 vetoed by the governor and subsequently approved by the legislature, this Act shall become 23 effective on the day following such approval.

Abstract: Requires that certain firefighters and fire service employees be provided cancer screening examinations.

CODING: Words in struck through type are deletions from existing law; words underscored are additions.

<u>Proposed law</u> requires that classified firefighters employed as full-time paid employees of municipal or parish fire departments or fire protection districts, fire service employees employed by non profit corporations under contract with fire protection districts, and volunteer firefighters as defined in <u>present law</u> (R.S. 23:1036) be provided cancer screening examinations.

<u>Proposed law</u> requires that the cancer screenings examinations be conducted by a physician not less than three years after the start of employment or volunteer service and every three years thereafter during the course of employment or service.

<u>Proposed law</u> requires that the examination include, but not be limited to the following cancers:

- (1) Colon.
- (2) Lung.
- (3) Bladder.
- (4) Oral.
- (5) Thyroid.

<u>Proposed law</u> requires that retired firefighters and fire service employees be provided cancer screening examinations by their former employers pursuant to <u>proposed law</u>. Additionally requires employers and former employers to pay for the costs of cancer screening examinations.

<u>Proposed law</u> provides that no firefighter or fire service employee shall be required to participate in cancer screening examinations.

Effective upon signature of governor or lapse of time for gubernatorial action.
