CIVIL/LAW: Creates the Women's Safety and Protection Act

1	AN ACT
2	To enact Part I-A of Chapter 1 of Code Title I of Code Book I of Title 9 of the Louisiana
3	Revised Statutes of 1950, to be comprised of R.S. 9:55 through R.S. 9:65, relative
4	to women; to provide for the safety and protection of women; to provide relative to
5	distinctions between sexes; to provide for legislative intent; to provide for purposes;
6	to provide for definitions; to provide for a standard of review; to provide for causes
7	of action; to provide for application; to provide for remedies; and to provide for
8	related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Part I-A of Chapter 1 of Code Title I of Code Book I of Title 9 of the
11	Louisiana Revised Statutes of 1950, comprised of R.S. 9:55 through R.S. 9:65 is hereby
12	enacted to read as follows:
13	PART 1-A. WOMEN'S SAFETY AND PROTECTION ACT
14	<u>§55. Short title</u>

1	This Part shall be known as and may be cited as the "Women's Safety and
2	Protection Act".
3	<u>§56. Purpose</u>
4	The purpose of this Part is all of the following:
5	(1) To clarify and reconcile the meaning of sex, male, female, and related
6	terms in state law.
7	(2) To provide protections for women and girls against sexual assault,
8	harassment, and violence in correctional facilities, juvenile detention facilities,
9	domestic violence shelters, dormitories, and restrooms, or where women have been
10	traditionally afforded safety and protection from acts of abuse committed by
11	biological men.
12	§57. Legislative findings
13	The legislature finds and declares that:
14	(1) "Physical differences between men and women, however, are enduring:
15	'[T]he two sexes are not fungible; a community made up exclusively of one [sex] is
16	different from a community composed of both." United States v. Virginia, et al, 518
17	U.S. 515, 533 (1996), citing Ballard v. United States, 329 U.S. 187, 193 (1946).
18	(2) The United States Supreme Court has recognized that there are
19	"[i]nherent differences' between men and women", and that these differences
20	"remain cause for celebration, but not for denigration of the members of either sex
21	or for artificial constraints on an individual's opportunity" in United States v.
22	Virginia, et al, 518 U.S. 515, 533 (1996).
23	(3) The equal protection clause of the Fourteenth Amendment of the
24	Constitution of the United State of America allows for legislatures to enact facially
25	neutral laws of general applicability, such as biologically based definitions of sex.
26	(4) Biologically based definitions of sex have been consistently applied since
27	our nation's founding.
28	(5) Decades of opinions from the Supreme Court of the United States have
29	upheld the argument that biological distinctions between male and female are a

1	matter of scientific fact, and biological sex is an objectively defined category that has
2	obvious, immutable, and distinguishable characteristics.
3	<u>§58. Definitions</u>
4	For purposes of this part:
5	(1) "Boy" means a human male who is a minor.
6	(2) "Changing room" means a room or area in which a person may be in a
7	state of undress in the presence of others, including a locker room or shower room.
8	(3) "Correctional facilities" means a correctional facility owned and operated
9	by the state or the Louisiana Correctional Facilities Corporation housing prisoners
10	committed to the custody of the Department of Public Safety and Corrections.
11	(4) "Domestic violence shelter" means a community-based shelter for
12	victims of domestic violence that is managed by the Department of Children and
13	Family Services.
14	(5) "Father" means a parent who is of the male sex.
15	(6) "Female" means an individual whose biological reproductive system is
16	developed to produce ova; who has, had, will have or would have, but for a
17	developmental or genetic anomaly or historical accident the reproductive system that
18	at some point produces, transports, and utilizes eggs for fertilization.
19	(7) "Girl" means a human female who is a minor.
20	(8) "Juvenile Detention facilities" means a correctional facility that houses
21	minor prisoners including the Louisiana Training Institute for Juveniles and its
22	extension locations.
23	(9) "Male" means an individual whose biological reproductive system is
24	developed to fertilize the ova of a female who has, had, will have or would have, but
25	for a developmental or genetic anomaly or historical accident the reproductive
26	system that at some point produces, transports, and utilizes sperm for fertilization.
27	(10) "Man" means a human male that has reached the age of majority.
28	(11) "Mother" means a parent who is a member of the female sex.

1	(12) "Public school" means a school which is created pursuant to R.S.
2	17:1371 and R.S. 17:3971, et seq.
3	(13) "Restroom" means a room that includes one or more toilets or urinals.
4	(14) "Sex" means an individual biological sex, either male or female, as
5	observed or clinically verified at birth. Gender identity and other subjective terms
6	shall not apply to this Part and shall not be used as synonyms or substitutes for sex.
7	(15) "Sleeping quarters" means a room with more than one bed and in which
8	more than one individual is housed overnight.
9	(16) "Woman" means a human female who has reached the age of majority.
10	§59. Application of definitions; distinctions between the sexes
11	Notwithstanding any other provision of law to the contrary, any provision of
12	law enacted by the legislature or any rule adopted by a state agency or other entity
13	subject to the Administrative Procedures Act when applicable to an individual's sex
14	shall apply those definitions provided in R.S. 9:58.
15	§60. Safety and privacy of women and girls in facilities designated for biological
16	females
17	Notwithstanding any other provision of law to the contrary, no governmental
18	agency, as defined in R.S. 42:1102(2), shall prohibit distinctions between the sexes
19	with respect to athletics, correctional facilities, juvenile detention facilities, domestic
20	violence shelters, or other accommodation where biology, safety, or privacy are
21	implicated and that result in separate accommodations that are substantially related
22	to the important government interest of protecting the health, safety, and privacy of
23	individuals in such circumstances.
24	§61. Safety and Privacy in Domestic Violence Shelters
25	A. A domestic violence shelter shall designate each multi-occupancy
26	restroom, changing room, and sleeping quarters for the exclusive use of any one of
27	the following:
28	(1) Females.
29	(2) Males.

1	(3) Members of the same family.
2	B. A restroom, changing room, or sleeping quarters within a domestic
3	violence shelter that is designated for females or males shall be used only by
4	members of that sex. No individual shall enter a restroom, changing room, or
5	sleeping quarter that is designated for females or males unless he or she is a member
6	of that sex.
7	C. The domestic violence shelter shall take reasonable steps to provide
8	individuals with privacy in restrooms, changing rooms, and sleeping quarters from
9	members of the opposite sex.
10	D. This Section shall not apply to an individual who enters a restroom,
11	changing room, or sleeping quarters designated for the opposite sex in any of the
12	following circumstances:
13	(1) To perform custodial services or maintenance of a restroom, changing
14	room, or sleeping quarters that is normally used by the opposite sex.
15	(2) To render medical assistance.
16	(3) To render assistance by law enforcement.
17	(4) To provide services or render aid during a natural disaster, a declared
18	emergency, or when necessary to prevent a serious threat to good order or safety.
19	E. Nothing in this Section shall be construed to prohibit a domestic violence
20	shelter from adopting policies necessary to accommodate persons protected under
21	the Americans with Disabilities Act or young children in need of physical assistance
22	when using restrooms, changing facilities, or sleeping quarters.
23	§62. Safety and Privacy in Restrooms of Public Schools
24	A. A public school shall designate each restroom or changing room for the
25	exclusive use of either females, males, or members of the same family.
26	B.(1) A restroom or changing room within a public school that is designated
27	for males or females shall be used only by members of that same sex. No individual
28	shall enter a restroom or changing room that is designated for one sex unless he or
29	she is a member of that sex.

1	(2) The public school shall take reasonable steps to provide individuals with	
2	privacy in restrooms and changing rooms from members of the opposite sex.	
3	C. During any public school authorized activity or event where students	
4	share sleeping quarters, no student shall share sleeping quarters with a member of	
5	the opposite sex, unless such persons are members of the same family, such as a	
6	parent, legal guardian, sibling, or grandparent and the student has received approval	
7	from the parent or legal guardian to do so.	
8	D. In any other public school facility or setting where a person may be in a	
9	state of undress in the presence of others, school personnel shall provide separate,	
10	private areas designated for use by persons based on their sex, and no person shall	
11	enter these private areas unless he or she is a member of the designated sex.	
12	E. This Section shall not apply to an individual who enters a restroom,	
13	changing room, or sleeping quarters designated for the opposite sex in any of the	
14	following circumstances:	
15	(1) To perform custodial services or maintenance of a restroom, changing	
16	room, or sleeping quarters that is normally used by the opposite sex.	
17	(2) To render medical assistance.	
18	(3) To render assistance by law enforcement.	
19	(4) To provide services or render aid during a natural disaster, a declared	
20	emergency, or when necessary to prevent a serious threat to good order or safety.	
21	F. Nothing in this section shall be construed to prohibit a public school from	
22	adopting policies necessary to accommodate persons protected under the Americans	
23	with Disabilities Act or young children in need of physical assistance when using	
24	restrooms, changing facilities, or sleeping quarters.	
25	§63. Safety and Privacy in Correctional Facilities and Juvenile Detention Facilities	
26	A. A correctional facility or juvenile detention facility shall designate each	
27	multi-occupancy restroom, changing room, and sleeping quarters for the exclusive	
28	use of either females, males, or members of the same family.	

1	B.(1) A restroom, changing room, or sleeping quarters within a correctional
2	facility or juvenile detention facility that is designated for females or males shall be
3	used only by members of that sex. No individual shall enter a restroom, changing
4	room, or sleeping quarter that is designated for females or males unless he or she is
5	a member of that sex.
6	(2) A correctional facility or juvenile detention facility shall take reasonable
7	steps to provide individuals with privacy in restrooms, changing rooms, and sleeping
8	quarters from members of the opposite sex.
9	C. This Section shall not apply to an individual who enters a restroom,
10	changing room, or sleeping quarters designated for the opposite sex in any of the
11	following circumstances:
12	(1) To perform custodial services or maintenance of a restroom, changing
13	room, or sleeping quarters that is normally used by the opposite sex.
14	(2) To render medical assistance.
15	(3) To render assistance by law enforcement.
16	(4) To provide services or render aid during a natural disaster, a declared
17	emergency, or when necessary to prevent a serious threat to good order or safety.
18	D. Nothing in this Section shall be construed to prohibit a correctional
19	facility or juvenile detention facility from adopting policies necessary to
20	accommodate persons protected under the Americans with Disabilities Act or young
21	children in need of physical assistance when using restrooms, changing facilities, or
22	sleeping quarters.
23	<u>§64. Standard of review</u>
24	Any law that distinguishes between the sexes in furtherance of the provision
25	of this Part is subject to intermediate scrutiny which forbids discrimination against
26	similarly situated individuals, but allows the law to distinguish between the sexes
27	when there is an important governmental interest.
28	§65. Remedies; rebuttable presumption; cause of action

1	A. A female who suffers, or is likely to suffer, from any direct or indirect	
2	harm as a result of a violation of this Part may assert that violation as a cause of	
3	action for remedies provided for in Subsection E of this Section.	
4	B. Any person who contracts with an agency, as defined in R.S. 42:1102(2)	
5	of government to provide services for biological females at a domestic violence	
6	shelter, juvenile detention center, corrections facility, or public school that is	
7	operated at the direction of, and receives funding from, the state, a local	
8	governmental subdivision, or a political subdivision shall have a cause of actio	
9	against the agency of the public servant who directed the contractor to violate th	
10	provisions of this Part.	
11	C. A person who is subjected to retaliation or other adverse action by	
12	asserting rights that affirmed by this Part shall have a cause of action for remedies	
13	provided for in Subsection E of this Section.	
14	D. It is a rebuttable presumption that requiring biological females to be	
15	housed with biological males at a domestic violence shelter, juvenile detention	
16	center, corrections facility, or public school that is subject to the provisions of thi	
17	Part is inherently discriminatory to biological females and is a cognizable harm t	
18	biological women under this Part.	
19	E. Any person who brings a cause of action pursuant to this Part may obtain	
20	appropriate relief, including but not limited to:	
21	(1)(a) Injunctive relief, protective order, writ of mandamus or a prohibition,	
22	or declaratory relief to prevent any violation of this Part.	
23	(b) The court may waive the requirement that the petitioner post bond for	
24	good cause shown.	
25	(2) Actual damages, reasonable attorney fees, and costs.	
26	F. All civil actions under this Part shall be initiated within two years from	
27	the date that the harm occurred.	
28	Section 2. If any provision or item of this Act, or the application thereof, is held	
29	invalid, such invalidity shall not affect other provisions, items, or applications of the Act	

- 1 which can be given effect without the invalid provision, item, or application and to this end
- 2 the provisions of this Act are hereby declared severable.

Abstract: Provides for the distinction between males and females and provides for protections for women and girls against sexual assault and harassment committed by biological men.

<u>Proposed law</u> provides legislative intent, and provides for protections for women and girls against sexual assault and harassment committed by biological men.

<u>Proposed law</u> defines "boy", "changing room", "correctional facilities", "domestic violence shelter", "father", "female", "girl", "juvenile detention facilities", "male", "man", "mother", "public school", "restroom", "sex", "sleeping quarters", and "woman".

<u>Proposed law</u> (R.S. 9:60) provides that no governmental agency shall prohibit distinction between the sexes with respect to athletics, correctional facilities, juvenile detention facilities, domestic violence shelters or other accommodation where biology safety, or privacy are implicated and that result in separate accommodations that are substantially related to the important government interest of protecting health, safety, and privacy of individuals in such circumstances.

<u>Proposed law</u> (R.S. 9:61) provides that a domestic violence shelter shall designate separate areas to be used by the members of each sex only, but shall not apply to the following circumstances:

- (1) To perform custodial services or maintenance of a restroom, changing room ,or sleeping quarters that is normally used by the opposite sex.
- (2) To render medical assistance.
- (3) To render assistance by law enforcement.
- (4) To provide services or render aid during a natural disaster, a declared emergency, or when necessary to prevent a serious threat to good order or safety.

<u>Proposed law</u> does not prevent a domestic violence shelter from accommodating with the provisions of the ADA.

<u>Proposed law</u> (R.S. 9:62) provides that restrooms in public schools shall designate separate restrooms to be used by the members of each sex only, but shall not apply to the following circumstances:

- (1) To perform custodial services or maintenance of a restroom, changing room ,or sleeping quarters that is normally used by the opposite sex.
- (2) To render medical assistance.
- (3) To render assistance by law enforcement.

(4) To provide services or render aid during a natural disaster, a declared emergency, or when necessary to prevent a serious threat to good order or safety.

<u>Proposed law</u> (R.S. 9:62(C))provides that students shall not share sleeping quarters with a member of the opposite sex on school authorized events unless such persons are members of the same family and the student has received approval from the parent or legal guardian to do so.

<u>Proposed law</u> does not prevent public schools from accommodating with the provisions of the ADA.

<u>Proposed law</u> (R.S. 9:63) provides that correctional facilities and juvenile detention facilities shall designate separate areas to be used by the members of each sex only, but shall not apply to the following circumstances:

- (1) To perform custodial services or maintenance of a restroom, changing room ,or sleeping quarters that is normally used by the opposite sex.
- (2) To render medical assistance.
- (3) To render assistance by law enforcement.
- (4) To provide services or render aid during a natural disaster, a declared emergency, or when necessary to prevent a serious threat to good order or safety.

<u>Proposed law</u> (R.S. 9:63(D)) does not prevent correctional facilities and juvenile detention facilities from accommodating with the provisions of the ADA.

<u>Proposed law</u> (R.S. 9:64) provides that any law that distinguishes between sexes is subject to intermediate scrutiny which forbids discrimination against similarly situated individuals, but allows the law to distinguish between the sexes when there is an important governmental interest.

<u>Proposed law</u> (R.S. 9:65(D)) provides that is it a rebuttable presumption that requiring biological females to be housed with biological males at a domestic violence shelter, juvenile detention center, corrections facility, or public school is inherently discriminatory to biological females and is a cognizable harm to biological women.

Proposed law (R.S. 9:65) provides for appropriate relief in the following circumstances:

- (1)(a) Injunctive relief, protective order, writ of mandamus or a prohibition, or declaratory relief to prevent any violation of this Part.
- (b) The court may waive the requirement that the petitioner post bond for good cause shown.
- (2) Actual damages, reasonable attorney fees, and costs.

<u>Proposed law</u> (R.S. 9:65(F)) provides that all actions shall be initiated within two years from the date that the harm occurred.

<u>Proposed law</u> provides that if any provision of the act is held invalid, application of this Act is declared severable.

(Adds R.S. 9:55 through 65)
