Provides for the reporting of federal funds and grants or programs to the Joint Legislative Committee on the Budget

<u>Proposed law</u> provides for the Division of Administration (Division) to submit information to the Joint Legislative Committee on the Budget (JLCB) regarding any federal funding and grants or programs supported by any federal assistance from any federal agency. Further provides for the information, by agency, of any federal funding or grants or programs the agency intends to apply for. Further provides for the information to be submitted on a form prescribed by the Division and approved by JLCB. The Division shall submit and present the information at the first meeting of JLCB after January 1st of each year. <u>Proposed law</u> authorizes JLCB to make studies and hearings to review Federal funds and grants or programs.
