Creates the Alzheimer's and Related Dementias Advisory Council within the Louisiana Department of Health. (gov sig)

Proposed law creates the Alzheimer's and Related Dementias Advisory Council within LDH.

Proposed law provides that the council be governed by 21 specific members. Members of the council shall serve 4 year terms, eligible for reappointment.

Proposed law provides that council members shall not receive compensation or a per diem for their services or attendance at meetings, except for travel-related expenses provided by the agency. LDH shall provide administrative support for the council, including staff, facilities, and resources to facilitate remote participation if necessary. Proposed law provides for responsibilities of the council, including development and implementation of a 5 year statewide plan to address Alzheimer's. The council shall submit a 5 year statewide plan relative to Alzheimer's, and further submit an annual report annually.
