**Abstract:** Provides relative to the salary requirement for membership in the Sheriffs' Pension and Relief Fund (fund).

<u>Present law</u> provides that each sheriff is member of the fund. Provides that each deputy sheriff becomes a member if he is at least 18 years old and meets a minimum monthly salary threshold. Provides that state supplemental pay is included in the determination of a deputy's salary.

<u>Present law</u> provides various minimum monthly salary thresholds which are applicable based on the date the person was employed. Provides that the threshold is \$1,000 for those employed subsequent to Dec. 31, 2012.

<u>Proposed law</u> provides that the threshold is \$1,250 for those employed subsequent to June 30, 2024.

Effective upon signature of governor or lapse of time for gubernatorial action.
