Provides for appointment of an ad hoc judge for election contests and challenges. (8/1/24)

<u>Current law</u> provides the procedure for objections to candidacy, election contests, and challenges. Current administrative rules of the Louisiana Supreme Court include rules regarding the appointment of ad hoc judges. <u>Proposed law</u> provides that when there is an objection to a candidacy, contest of an election, or contest of a certification of a recall petition, the Louisiana Supreme Court shall appoint as an ad hoc judge, a sitting or retired judge whose judicial district is noncontiguous and nonadjacent to the parish in which the election challenge or contest initiated.

The Louisiana Supreme Court advises that the situation contemplated within the <u>proposed law</u> is rare, and that to the extent an ad hoc judge that is a sitting or retired judge (whose judicial district is noncontiguous and nonadjacent to the parish in which an election challenge or contest is initiated) would be appointed, the expenditures incurred by the Louisiana Supreme Court would not exceed \$500.
