11	workforce to meet the needs of the economy. The commission shall coordinate and
12	administer programs conducted by the state, or jointly with federal agencies, in the
13	area of labor-management relations, manpower evaluation and training, vocational
14	rehabilitation, independent living, blind services, employment, unemployment and
15	workers' compensation, job safety, and the licensing and regulation of certain types
16	of work. The commission shall be responsible for delivering workforce
17	development solutions for businesses and economic sectors of the economy, and
18	<u>coordinating with other state agencies and offices for the delivery of workforce</u>
19	development solutions, as provided for in R.S. 23:1801. The commission shall
20	perform functions related to administration of the community services block grant
21	for which provision is initially made in the Omnibus Budget Reconciliation Act of
22	1981.

24	(2) Except when changes are necessary for the efficient delivery of
25	workforce development solutions for businesses and economic sectors of the
26	economy, whenever Whenever the secretary determines that the administration of
27	the functions of the commission may be more efficiently performed by eliminating,
28	merging, or consolidating existing offices or establishing new offices, he shall
29 20	present a plan therefor to the legislature for its approval by statute. *

31	§304. Powers and duties of secretary A. In addition to the functions, powers, and duties otherwise vested in the

34	(10) Be responsible for directing statewide workforce solutions and

37	economic sectors and regions of the state, in coordination with the secretary of
