2	To amend and reenact R.S. 4:144(B)(2) and (C), relative to the members of the Louisiana
3	State Racing Commission; to provide for the ownership of racehorses; to provide for
4	the per diem rates for commission members; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 4:144(B)(2) and (C) are hereby amended and reenacted to read as
7	follows:
8	§144. Louisiana State Racing Commission; creation; membership; tenure; powers

14	(2)(a) No member shall be an official, member of any board of directors, or
15	person financially interested in any race track or race meeting licensed by the
16	commission. Except as provided in Subparagraph (b) of this Paragraph, no member
17	may directly or indirectly own racehorses which participate in any race meeting

**Abstract:** Provides relative to the members of the Louisiana State Racing Commission.

<u>Present law</u> provides that no member of the La. State Racing Commission (commission) may directly or indirectly own racehorses which participate in any race meeting licensed by the commission except for the three members that shall be owners of racehorses which participate in any race meeting licensed by the commission.

Proposed law repeals present law.

<u>Present law</u> provides that members of the commission shall serve without salary, but shall receive a per diem at the rate of \$50 per day while attending official meetings, regular or special, of the commission called by the chairman, or in his absence, one of the vice chairmen, not to exceed \$2000 per annum.

<u>Proposed law</u> amends <u>present law</u> to increase the per diem <u>from</u> \$50 <u>to</u> \$100 per day and to increase the per annum amount <u>from</u> \$2000 <u>to</u> \$4000.
