The administrative fee 15 includes all services related to the contract including but not limited to appeals, 16 clinical programs, and other communications, eligibility maintenance, explanation 17 of benefits, formulary customizations, member grievances and call centers, on-site 18 audits and surveys, prior authorizations and step therapy, trend management, and benchmark reporting and transaction fees. The administrative fee does not include 19 20 pass-through claims.
- 21 (4) "Revenues" means all financial benefits an administrator or pharmacy
 22 benefit manager receives related to utilization or enrollment in programs offered by
 23 the office. These include but are not limited to access fees, market share fees,
 24 formulary access fees, inflation protection and penalty payments, and marketing
 25 grants from pharmaceutical manufacturers, wholesalers, and data warehouse
 26 vendors. "Revenues" also means any financial benefit received by an administrator
- or pharmacy benefit manager attached to a rebate."
