ELECTIONS/ABSENTEE VOTE: Provides relative to the preparation, verification, tabulation, and counting of absentee by mail and early voting ballots

AN ACT

2 To amend and reenact R.S. 18:423(I), 1302(2), 1313(B), and 1313.1(B), relative to the 3 meetings of the parish board of election supervisors; to provide for notice of 4 meetings; to provide for the preparation, verification, tabulation, and counting of 5 absentee by mail and early voting ballots; to provide for the preparation, verification, 6 tabulation, and counting process without a majority of parish board of election 7 supervisors present; to provide for the selection of parish board commissioners to 8 provide assistance; to provide for the authorization of the commissioner of elections; 9 and to provide for related matters. 10 Be it enacted by the Legislature of Louisiana: 11 Section 1. R.S. 18:423(I), 1302(2), 1313(B), and 1313.1(B) are hereby amended and 12 reenacted to read as follows: 13 §423. Parish boards of election supervisors 14 15 I. Meetings. Each parish board of election supervisors shall conduct its 16 business in the presence of a quorum. All members of the board must be given 17 actual notice of all board meetings no later than twenty-four hours, exclusive of 18 Saturdays, Sundays, and legal holidays, before each meeting. 19

| 14 | preparation, verification, counting, and tabulation of all absentee by mail and early |
| 15 | voting ballots in the parish. The board may utilize parish board commissioners to |
| 16 | count the absentee by mail and early voting ballots in the parish. If the board |
| 17 | determines that parish board commissioners are necessary to prepare, verify, count |
| 18 | and tabulate the absentee by mail and early voting ballots, it shall select parish board |

§1313.1. Preparation, verification, tabulation, and counting of absentee by mail and early voting ballots

3 * * *

B.(1) The parish board of election supervisors shall be responsible for the preparation, verification, counting, and tabulation of all absentee by mail and early voting ballots in the parish. The board may utilize parish board commissioners to count the absentee by mail and early voting ballots in the parish. If the board determines that parish board commissioners are necessary for the preparation and verification process to count and tabulate the absentee by mail and early voting ballots before the election and to count and tabulate the absentee by mail and early voting ballots on election day, it shall select parish board commissioners in accordance with the provisions of R.S. 18:1314.

(2) If less than a majority but at least two of the members of the board are not present for the preparation and verification process to count the absentee by mail and early voting ballots or to count the absentee by mail and early voting ballots and no parish board commissioners were previously selected, the members present may and the board cannot locate an alternate designee or appointee, the board shall, through the registrar of voters, so inform the commissioner of elections and request approval from the commissioner of elections for the appointment of a parish board commissioner to serve as a board member. The board shall receive approval of the commissioner of elections before proceeding with the preparation and verification process without a majority present.

(3) If an insufficient number of parish board commissioners was previously selected for the preparation and verification process or to count the absentee by mail and early voting ballots, the board, through the registrar of voters, may request approval from the commissioner of election to select a sufficient number of parish board commissioners three days before the election or on election day, as applicable, to assist in the preparation and verification process for the tabulation and counting

Abstract: Provides for the procedure for selecting parish board commissioners to assist the parish board of election supervisors with the preparation, verification, tabulation, and counting of absentee by mail and early voting ballots and for notice of meetings of the board of election supervisors.

<u>Present law</u> requires each parish board of election supervisors to conduct its business in the presence of a quorum, subject to the Open Meetings Law (R.S. 42:11, et seq.), which requires written public notice of any regular, special, or rescheduled meeting not later than 24 hours, exclusive of Saturdays, Sundays, and legal holidays, before the meeting.

<u>Proposed law</u> requires that all members of the board must be given actual notice of all board meetings not later than 24 hours before each meeting.

<u>Present law</u> requires the parish board of election supervisors to conduct the preparation verification, tabulation, and counting of absentee by mail and early voting ballots in the parish. Authorizes the board to utilize and select parish board commissioners to count the ballots. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> requires a majority of the parish board of election supervisors to be present to determine whether an absentee by mail or early voting ballot is invalid and requires the inspection by a candidate of certificates removed from valid absentee by mail and early voting ballots be done in the presence of a majority of the parish board of election supervisors. <u>Proposed law</u> retains <u>present law</u>.

When the preparation verification, tabulation, and counting is conducted on election day and a majority of the members of the board are not present and no parish board commissioners were previously selected, <u>present law</u> (R.S. 18:1313) authorizes the members present to select a sufficient number of parish board commissioners on election day to assist.

<u>Proposed law</u> instead requires the board, through the registrar of voters, to receive approval from the commissioner of elections to select a sufficient number of commissioners to assist.

<u>Present law</u> (R.S. 18:1313.1) authorizes parishes to conduct preparation and verification the day prior to the election and conduct tabulation and counting on election day. In such circumstances, if less than a majority of the parish board members are present, <u>present law</u> authorizes the members present to select a sufficient number of parish board commissioners three days before the election or on election day, as applicable, to assist in both the preparation and verification process and the tabulation and counting of the ballots.

<u>Proposed law</u> instead provides that if less than a majority but at least two of the members of the board are present for the preparation and verification process and the board cannot locate an alternate designee or appointee, the board shall, through the registrar of voters, so inform the commissioner of elections and request approval from the commissioner of elections for

the appointment of a parish board commissioner to serve as a board member. The board shall receive approval of the commissioner of elections before proceeding with the preparation and verification process without a majority present.

<u>Proposed law</u> also provides that if an insufficient number of parish board commissioners were previously selected for the preparation and verification process or to count the absentee by mail and early voting ballots, the board, through the registrar of voters, may request approval from the commissioner of election to select a sufficient number of parish board commissioners three days before the election or on election day, as applicable, to assist in the preparation and verification process for the tabulation and counting of absentee by mail and early voting ballots and the tabulation and counting of the ballots.
