Liability for loss related to bonfire presentations on the Mississippi River 8 levee 9 A.(1) Personal injury, wrongful death, and survivorship actions for damages 10 Notwithstanding any other law to the contrary, no person shall have a cause of action 11 against a sponsor of a bonfire presentation on the Mississippi River levee in 12 connection with any festival or ethnic or holiday celebration shall be available to the 13 plaintiff. 14 (2) if If the sponsor of the bonfire failed to obtain and comply with a permit 15 for the bonfire presentation, failed to use only combustible materials approved by the 16 local governing authority, negligently violated an order from the local governing 17 authority, or committed a deliberate and wanton act or gross negligence, and such 18 conduct of the sponsor was the cause in fact of the injury, death, or loss sustained by 19 the plaintiff a person may bring an action against the sponsor. 20

Abstract: Provides for a limitation on cause of action for loss related to bonfire presentations on the Mississippi River levee.

<u>Present law</u> provides that personal injury, wrongful death, and survivorship actions for damages against a sponsor shall be available if the sponsor fails to comply with a permit for bonfire presentation, failed to use the proper materials, negligently violated an order from the local authority, or committed a deliberate and wanton act or gross negligence and the sponsor was the cause in fact of the injuries.

<u>Proposed law</u> changes <u>present law</u> to provide that no person shall have a cause of action against a sponsor unless the sponsor fails to comply with a permit for bonfire presentation, failed to use the proper materials, negligently violated an order from the local authority, or committed a deliberate and wanton act or gross negligence, and the sponsor was the cause in fact of the injuries.
