DOTD indicates that proposed law codifies current practice and will allow the DOTD Police Force to operate more effectively. The department reports that the majority of the current officers are P.O.S.T. certified and they have the funds to cover the certification of those who are not. In addition, the department is able to absorb any costs related to the name change (i.e. uniforms, signage) in their operating budget.
