Proposed legislation increases licensing fees for technical endorsements of locksmiths. The measure increases initial fees from \$250 to \$300 and renewal fees from \$50 to \$100. Proposed legislation increases permit fees for retailers to sell fireworks from \$100 to \$250.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

Proposed legislation will increase revenues generated from various increases in fees in the Department of Public Safety (DPS), Office of Fire Marshal. This measure increases the initial licensing fee on firms for technical endorsements of locksmiths from \$250 to \$300 as well as renewal fees from \$50 to \$100. This measure also increases retail permit fees for applicants engaging in the sale of fireworks from \$100 to \$250. DPS reports an estimated three (3) initial licenses and 104 renewals annually for technical endorsements of locksmiths. Also, DPS estimates that 1,168 applicants for retail permits to engage in the sale of fireworks are received and processed each year. The table below reports the revenue impact for FY 25.
