20	§100.241. Louisiana Equine Promotion and Research Fund
21	A. There is hereby created, as a special fund in the state treasury,
22	<u>the Louisiana Equine Promotion and Research Fund, hereafter referred</u>
23	to in this Section as the "fund".
24	B.(1) After compliance with the requirements of Article VII,
25	Section 9(B) of the Constitution of Louisiana, the fund shall consist of
26	monies deposited into the fund pursuant to the requirements of R.S.
27	27:625(G)(7) and any other monies appropriated annually by the
28	legislature including donations, gifts, grants, or any other monies which
29	may be provided by law.
30	(2) Monies in the fund shall be invested by the treasurer in the
31	same manner as monies in the state general fund, and interest earned on
32	investment of the monies shall be credited to the fund. All unexpended
33	and unencumbered monies in the fund at the end of the fiscal year shall
34	<u>remain in the fund.</u>
35	C. Monies in the fund shall be appropriated to the Department
36	of Agriculture and Forestry for the Louisiana Equine Promotion and
37	Research Program in accordance with the provisions of R.S. 3:2076 and
38	<u>2077.</u> "
