AN ACT 1 2 To enact R.S. 17:440.3, relative to emergency training and certifications for coaches; to require elementary and secondary school coaches to have certain certifications; to 3 provide for limitation of liability; and to provide for related matters. 4 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 17:440.3 is hereby enacted to read as follows: 7 §440.3. School coaches; required certifications 8 A. Beginning in the 2025-2026 school year, any high school employee who 9 serves as a coach for the school shall obtain and maintain certification in 10 cardiopulmonary resuscitation, first aid, and automatic external defibrillator 11 use. The certification shall be consistent with the American Heart Association, American Red Cross, or other national evidence-based emergency 12 13 cardiovascular care guidelines. 14 B. The provisions of R.S. 9:2793 shall apply to any coach who is certified 15 pursuant to this Section and performs cardiopulmonary resuscitation or first 16 aid or uses an automatic external defibrillator in his capacity as a school coach. C.(1) It is the intention of this legislature that this Section shall not create 17

an unfunded mandate on any city, parish, and other local public school board.

(2) The provisions of this Section shall not apply to any city, parish, or

other local public school board until one of the following occurs:

(a) The legislature appropriates funds in an amount necessary to

implement the provisions of this Section.

(b) Grants or other private donations are made to the school to pay for

the costs of implementing the provisions of this Section.

<u>Proposed law</u> requires that, beginning in the 2025-2026 school year, any high school employee who serves as a coach for the school must obtain and maintain certification in CPR, first aid, and AED use.

<u>Proposed law</u> requires the certification to be consistent with the American Heart Association, American Red Cross, or other national evidence-based emergency cardiovascular care guidelines.

<u>Proposed law</u> provides for a limitation of liability for any coach who performs cardiopulmonary resuscitation or first aid or uses an automatic external defibrillator in his capacity as a school coach.

<u>Proposed law</u> provides that it will not apply to any city, parish, or other local public school board until the legislature appropriates the necessary amount of funds to implement the law or grants or other private donations are made to the school to pay for costs of implementation.

Effective August 1, 2024.
