FISHING/CRAWFISH: Makes changes to the Louisiana Crawfish Promotion and Research Board

AN ACT

2	To amend and reenact R.S. 3:556.3(B)(introductory paragraph), (5), and (6) and (C), (F),
3	and (H), relative to the Louisiana Crawfish Promotion and Research Board; to
4	provide for changes in the membership of the board; to provide relative to the terms
5	of board members; to provide for changes in meeting requirements; and to provide
6	for and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 3:556.3(B)(introductory paragraph), (5), and (6) and (C), (F), and (H)
9	are hereby amended and reenacted to read as follows:
0	§556.3. Louisiana Crawfish Promotion and Research Board

12	B. The board shall consist of eleven thirteen members appointed by the
13	commissioner of agriculture and forestry in accordance with the following
4	provisions:

16	(5) One member Three members who is are engaged in crawfish farming or
17	crawfish harvesting appointed from a list of three six persons nominated by the
18	Louisiana Farm Bureau Federation.

1	(6) One member who is engaged in the crawfish industry appointed from a
2	list of three persons nominated by an owner or operator of a facility which produces
3	or sells artificial crawfish bait.

5	C. Members shall be appointed for terms concurrent with the term of the
6	commissioner of agriculture and forestry. Each appointment by the commissioner
7	shall be submitted to the Senate for confirmation.

9	F. A majority of the <u>appointed</u> members <u>who serve</u> of <u>on</u> the board shall
10	constitute a quorum for the transaction of business. All official actions of the board
11	shall require the affirmative vote of a majority of the members of the board present
12	and voting.

14	H. The board shall meet quarterly at least twice per calendar year and may
15	meet at other times on the call of the chairman or by request of any four members.
16	The board shall not receive per diem or mileage for more than twelve meetings in
17	any calendar year.

**Abstract:** Provides for changes in the membership and meeting requirements of the Louisiana Crawfish Promotion and Research Board and provides for a certain term for the members of the board.

<u>Present law</u> provides for the membership of the La. Crawfish Promotion and Research Board, consisting of 11 members appointed by the commissioner of agriculture and forestry.

Proposed law modifies present law by changing the number of members from 11 to 13.

<u>Present law</u> requires a member of the board who is engaged in crawfish farming or harvesting appointed from a list of three persons nominated by the La. Farm Bureau Federation.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed law</u> modifies <u>present law</u> by increasing the number of board members engaged in crawfish farming or harvesting <u>from</u> one <u>to</u> three and increases the number of nominees appointed by the La. Farm Bureau Federation <u>from</u> three <u>to</u> six.

<u>Present law</u> requires one member of the board who is an owner or operator of a facility that produces artificial crawfish bait.

<u>Proposed law modifies present law</u> by requiring the member be engaged in the crawfish industry and be appointed from a list of three nominees submitted by an owner or operator of a facility that also sells artificial crawfish bait.

<u>Present law</u> requires that each appointment made by the commissioner be submitted to the Senate for confirmation.

<u>Proposed law</u> modifies <u>present law</u> by requiring that members of the board be appointed for terms concurrent with the term of the commissioner of agriculture and forestry, otherwise retains <u>present law</u>.

<u>Present law</u> requires a majority of the members of the board to constitute a quorum for the transaction of business and requires an affirmative vote of a majority of the members who are present and voting for all official actions.

<u>Proposed law</u> modifies <u>present law</u> by specifying that the majority of the board members voting on a business transaction be members who are appointed and serving on the board.

<u>Present law</u> requires the board to meet quarterly and authorizes the board to meet at other times on the call of the chairman or the request of any four members. Prohibits the board from receiving per diem or mileage for more than twelve meetings in any calendar year.

<u>Proposed law</u> modifies <u>present law</u> by changing the frequency of the board meetings <u>from</u> quarterly to a minimum of two meetings per calendar year.
